**ORDER**

This order shall dispose of the representation dated 24.05.2022 filed by Sh. Joginder Singh (Roll No.4110000011), a candidate for the post of ECG Technician under Post Code-104/12 in NDMC in compliance of the directions of Hon'ble Central Administrative Tribunal order dated 01.06.2022 in OA No. 1485/2022, in the matter of Joginder Singh V/s Govt. of NCT of Delhi and Ors.

2. The Hon'ble Tribunal while disposing the Original Application No. 1485/2022 has directed to the respondents to decide the pending representation dated 24.05.2022 of the applicant within a period of six weeks from the receipt of a copy of the said order. Copy of the representation is found annexed with O.A. as Annexure A-1. The applicant vide his representation dated 24.05.2022 has stated as under:-

*"13. That the applicant is apprehensive that respondents are in process of advertising fresh recruitment for the abovementioned post as UR category has already joined respective service one year back. That even after a lapse of 24 months applicant has not been appointed to the post of ECG Technician."*

**Brief facts of the case**

As per requisition received from the NDMC, the DSSSB advertised the following vacancy vide its advertisement no. 02/2012 as per advertisement No. 02/2012 is as under:-

The prescribed cutoff date for determining the eligibility was closing date for receipt of applications i.e., 15/06/2012.

*AC*

Applicant in O.A. Sh. Joginder Singh had also applied for the said Post and his detail is as under:

It is submitted that Last selected candidate under UR category had obtained 115 marks and Last selected candidate under OBC category had obtained 103.5 marks. Therefore, the applicant could not be selected under UR category as well as under OBC category vide Result Notice No.893 dated 04.02.2020. Applicant was a waitlist 02 candidate in OBC category.

It is stated that the User Department i.e. NDMC vide letter No. D-588/SO(HE-II)SA-II dated 28.09.2020 (Addressed to Sh. Azim Ahmed) cancelled the candidature of Sh. Azim Ahmed (Roll No. 4110000013) and endorsed copy of same to DSSSB. The User Department neither returned the dossier of Sh. Azim Ahmed (Roll No. 4110000013) nor sought any fresh nomination in place of said Sh. Azim Ahmed.

It is also worthwhile to point out the reply of PIO (Health), NDMC given to Sh. Joginder in response to his RTI application. Sh. Joginder Singh has annexed the copy of the same in the O.A. at page No. 44. The information sought and reply is as under:

Further, Sh. Joginder Singh (Roll No. 4110000011) is Waitlist-2 candidate and not the Waitlist No. 1 candidate. Hence, the candidature of Sh. Joginder Singh (Roll No. 4110000011) against the cancelled candidature of Sh. Azim Ahmed (Roll No. 4110000011) cannot be considered for the post of ECG Technician under Post Code 104/12.

In view of above, the candidature of applicant in O.A. namely Sh. Joginder Singh (Roll No. 4110000011) cannot be considered for the Post of ECG Technician under Post Code 104/12.

*AC*

This issues with the approval of Competent Authority and in compliance of the directions of Hon'ble Central Administrative Tribunal vide order dated 0.06.2022 in O.A. No. 1485/2022.
