SUPPLEMENTARY RESULT NOTICE NO. 775 DATED 30.03.2021

TGT (ENGLISH), FEMALE POST CODE-132/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total **311 vacancies (UR-125, OBC-67, SC-57 & ST-62(including PH/OH-04 & PH/VH-05))** for the post of TGT (English), Female under Post code-132/17 in Directorate of Education with closing date as **31.01.2018**. Tier-I examination in offline examination was conducted on **08.09.2018**.

2. On the basis of offline examination of Tier-1 held on **08.09.2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT(English), Post Code-132/17 in Directorate of Education, 251 candidates (UR-116, OBC-54, SC-55, ST-22, PH/OH-02 & PH/VH-02)** were provisionally nominated vide Result Notice No.451 dated 28/05/2019, **15 candidates (UR-03,OBC-10,SC-02)** were provisionally nominated vide Supplementary Result Notice No.531 dated 09/10/2019, **02 candidates (UR-01 & OBC-1)** were provisionally nominated vide Supplementary Result Notice NO. 553 dated 03.12.2020 and **10 candidates (UR-06,OBC-01,SC-03)** were provisionally nominated Supplementary Result Notice No.612 dated 05/03/2020. Further, the dossier of **05 candidates [UR-04 and UR(PH-OH)-01]** had been returned by user department vide letter dated 28.02.2020 after cancellation of their candidature with the request to provide substitute from waiting panel. As per waiting list of UR category, 04 vacancies (OBC-03, SC-01) category were created due to lower of merit under UR category. Therefore, **08 candidates) UR-04, OBC-03, SC-01)** were provisionally nominated vide Supplementary Result Notice No. 689 dated 12.10.2020.

3. Further, the user department vide letter dated 17.07.2020 had returned 05 dossiers which received after expiry of waiting panel and accordingly, candidates in waiting panel could not be provided to the user Department. However, the waiting panel has been extended upto 31.12.2020, the candidates are being provided against these returned dossiers and against shifting of candidates in the merit.

4. Accordingly, in continuation to Result Notice No.451 dated 28/05/2019, Supplementary Result Notice No. 531 dated 09/10/2019, Supplementary Result Notice No.553 dated 03/12/2019, Supplementary Result Notice No. 612 dated 05/03/2020 & Supplementary Result Notice No. 689 dated 12.10.2020, the candidates, detailed below are also provisionally selected on the basis of offline examination of Tier-I held on 08.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of TGT(English) Post Code-132/17.

5. The selection of the above 06 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M.

No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

11. The result process for the above post code stands closed in all respect.

12. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 29.04.2020 as per earlier result notice no. 429 dated 30.04.2019 has been expired on 29.04.2020. However, the same has been extended upto 31.12.2020.

13. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

14. The category wise marks obtained by the last selected candidates have been given as under:-

Note:- In advertisement no. 04/17, in para-2 (vii) - Mode of Selection (Examination Scheme), it has been mentioned that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference. In case of further tie, candidate having higher marks in Section "A" of the test shall be preferred".
