The Competent Authority of the user department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. The selection/ appointment of above mentioned candidate shall further be subject to outcome of any court cases filed by any of the candidates whose candidature has been cancelled. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, it may also be verified that the candidate does not belong to the person/section (Creamy Layer) mentioned in column 3 of the schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No.36033/3/2004-Estt.(Res) dated 14.10.2008.
