In compliance of order dated 03/06/2016 (14/06/2016) of Ld. CAT passed in OA No. 4394/2012 titled as Solinder Kumar Tomer V/s DSSSB &Ors. The Ld. CAT while disposing the said order has directed that:-

"7. We are of the considered view that the instant OA is squarely covered by the order of this Tribunal dated 16/09/2011 in OA No. 3095/2010. The instant OA is accordingly disposed of on similar terms and directions. No order as to cast."

Further, while passing the order, Ld. CAT have relied upon the judgment of OA No. 3095/2010 titled as Neeraj Kumar V/s GNCTD &Ors. The operative part of the above judgment in OA No. 3095/2010 is as under:-

"8we also do not find any reasons to deviate from the findings in those OAs. Accordingly, we dispose of this OA with the direction to the respondents to verify and compare the signatures of the applicant herein the original application form with his signatures in other documents available with them and if it is found genuine, declare his result and offer him appointment as Teacher (Primary) in the MCD with all consequential benefits except back wages".

In compliance of the order dated 03/06/2016 of Ld. CAT and as per approval of the Chairperson, DSSSB, the samples of Thumb Impression and specimen signatures and writing of petitioner were sent to FSL vide this office letter dated 09/07/2019.

The FSL vide their letter dated 29/07/2021 has enclosed/sent 02 sealed report (opinion) in respect of the examination documents with reference letter dated 09/07/2019.

FSL in its reports inter-alia states:-

.....The aforesaid similarities in the writing habits are sufficient & significant to indicate the common authorship of the red enclosed writings/signatures Q1 to Q4 and S16 to S17.

3. *Questioned Thumb/Finger Impressions marked as QT-1, QT-3 and QT-4 are inter-se-identical and further identical with Specimen Left Hand Thumb Impression marked as LTI-2 on sheet marked as LT-2 of Sh. Solinder Kumar Tomer S/o Sh. Raghbir Singh.*

Accordingly, the candidate with following particulars has been provisionally selected to the post of Driver (DTC) in Delhi Transport Corporation, Govt. of NCT of Delhi in the par scale of Rs. 3200-4900 (Pre-revised) under post code 65/09 subject to his passing the medical examination requiring Height-162 CMs (Minimum) and vision 6/6 without glass and no colour blindness and as per medical standard for Driver prescribed by DTC.

The selection against advertisement vacancies in above post code was processed by the Board and result was declared vide result notices dated 06/12/2010 and 14/06/2011, 26/12/2011, 17/02/2012, 30/04/2012, 04/05/2012, 30/10/2013, 08/01/2014, 31/01/2014 and 10/02/2015, as per merit drawn on the basis of Written (Objective-One tier) Examination held on 14/03/2010 and 21/03/2010. The vacancies had been advertised by the Board as per requisitions of Delhi Transport Corporation, Govt. of NCT of Delhi vide advertisement No. 03/2009 with closing date of receipt of application as 02/12/2009.

Driving Skill Test Evaluation Boards as per provisions of RRs of the post, requiring the candidate to hold a valid Heavy Motor Vehicle License for at least three years, have considered candidates, who possessed valid HTV Driving License as on 03/12/2006 i.e. three years prior to the cut-off date, eligible to appear in the Skill test and declared the candidates passed subject to verification of their Driving License. As such, the nomination as above shall be subject to candidate's producing proof of issue/endorsement of their HTV driving license of period 03/12/2006 and prior to that date. In respect of candidates whose particulars as recorded in application form for the post varies to the particulars as indicated in the driving license, the Board nominating the candidates to the post with clear stipulation that veracity of driving license of such candidates shall be not verified from the RTO concerned, by the DTC authorities, before issue of offer of appointment.

As per the provision of RRs, selected candidate, who do not possess PSV badge issued/endorsed by STA-Delhi, will have to obtain the same within three months of their selection and this time period could further be extended by DTC on



merits. However, the Driver would actually start on line duty in DTC only after the required PSV badge is issued to him.

Selection of above 01 (one) candidate under UR category shall further be subject to the candidate found fulfilling the eligibility conditions as per RRs for the post up to the satisfaction of the appointing authority, for which documents as submitted with application forms and submitted at the time of driving skill test as placed in respective dossiers, shall be verified by the DTC authorities from the original ones/ issuing authority and also subject to verification of genuineness of candidature of the candidate through signatures/thumb impressions, as put up by the candidate in his application form, admit cards of written as well as skill test examination and handwriting submission obtained during driving skill test. Mere inclusion of name in the result notice dose not confer any right upon the candidate over the post.
