KIND ATTENTION:- Candidates for the Post of Radio Telephone Operator, Post Code-72/14 and uploading e-dossier – regarding.

The DSSSB vide its advertisement No. 01/14 had advertised **55 {UR-24, OBC-22, SC-02, ST-07}** for the post of **Radio Telephone Operator, Post Code-72/14 in Delhi Fire Service**. Further, vide addendum dated 01.11.2019, the notified vacancies have been revised as under:-

2. Tier-I online examination was held on 05.11.2019.

3. The marks obtained by 387 candidates who duly appeared in examination conducted (**online mode**) on **05.11.2019** have been uploaded on the Board's website and 132 shortlisted candidates were asked to upload their e-dossier **w.e.f. 17.03.2020 to 31.03.2020**.

4. However, the stipulated period of uploading of the e-dossier got scheduled during the period of lockdown w.e.f. 24.03.2020 to 18.05.2020 (date of first unlock) imposed due to COVID-19 pandemic by Govt. of India.

5. Further, a spate of representations have been received from such candidates seeking extension of time for uploading the documents and few of them have approached the Hon'ble CAT as well, which in turn has disposed off such applications with directions to the Board to dispose of the applications by passing appropriate speaking orders.

6. Therefore, after due deliberations, it has been decided that in view of the extra-ordinary circumstances arising out of the COVID-19 pandemic, wherein the entire country had to be placed in a lockdown w.e.f. 24.03.2020(Midnight) to 18.05.2020 and all physical movement of citizens were curtailed and all markets/services closed by Govt. of India and it was declared illegal to make any kind of movement, the candidates too were legally bound not to make any physical access to the computers/internet etc., they were physically restrained to seek any access to internet service providers such as Cyber Cafes or such I.T enabled services. Keeping in view of this fact of lockdown, the candidates who failed to upload their e-dossier during lockdown period, are being allowed another opportunity because of the above referred extraordinary circumstances **w.e.f. 10/09/2020 to 19/09/2020**. **However, the same shall not be quoted as precedent for any other case whatsoever.**

7. The shortlisted candidates for the above mentioned post code who failed to upload their e-dossier are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks.

8. Kindly note that the opening /activation of e-dossier link shall be applicable to only those candidates who are in the consideration zone of selection and failed to upload their e-dossier w.e.f. 17.03.2020 to 31.03.2020.

9. The e-dossier link shall be activated for a period of 10 days w.e.f. 10/09/2020 to 19/09/2020.

10. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **27.02.2014**. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. as an additional facility. If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.

11. Mere asking the candidate for uploading documents in the e-dossier module does not confer him any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.

12. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

13. The above short listing candidates for calling of e-dossier for the post of **Radio Telephone Operator, Post Code-72/14 in Delhi Fire Service** is subject to outcome of pending court case, if any.
