The Board had conducted Tier-I (T) written examination on 27th 28th, 29th 30th August 2019 and 30th September 2019(online).
2. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be 'Not Eligible' in terms of the advertisement no. 02/2018 and Recruitment Rules for the post of Nursing Officer under post code 03/18 in Health & Family Welfare Department, GNCTD.
