1. The DSSSB vide its advertisement no. 01/2017 with closing date 21/08/2017 had advertised 52 vacancies {UR-27, OBC-16, SC-05, ST-04 including 01 EXSM, 01 PH (OH) & 02 PH (HH)} for the Post of Draughtman Grade - III under post code 6/17 in Delhi Jal Board.
2. The written examination (online mode in single shift) Tier-I for recruitment in respect of this post was conducted on 27th November, 2019.
3. DSSSB vide Result Notice No. 1008 dated 15/07/2020 has provisionally selected 19 candidates for the post of Draughtsman Grade III under post code 06/17 in Delhi Jal Board.
4. Further candidature of 04 candidates having Roll Nos 11172700163 in UR Category, Roll Nos. 1172700420 & 12332700304 in OBC Category and Roll Nos. 11142700005 in PH(OH)OL Category, were kept pending vide Result Notice No. 1008 dated 15.07.2020 for want of deficient/requisite documents. These candidates were directed to upload their deficient documents through their e-dossier module which was active from 24/07/2020 to 02/08/2020. Now out of 04 candidates 02 candidates have uploaded/submitted their deficient/requisite documents in their respective e-dossier. In view of additional documents furnished by these 02 candidates, whose candidature was kept pending for required documents, after preliminary scrutiny of the deficient documents submitted by the candidates, as per the provisions of the statutory Recruitment Rules and terms and conditions of the advertisement, the following candidates are hereby provisionally nominated as per their merit:

* Note: That as per RRs, essential qualification is "Matriculation or its equivalent from a Board or institution recognized by State/Central Govt. and two Years Diploma in Draftsmanship from recognized institutions", since the essential qualification related to two Years Diploma in Draftsmanship from recognized institutions is technical in nature therefore, at this stage DSSSB has not undertaken the veracity/scrutiny of the essential education qualification furnished by the candidates as such User Department i.e. DJB, GNCTD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate as per nature of job and requirements of the Department. The selection is provisional and subject to

satisfaction of User Department regarding essential qualification furnished by above candidates.

- 5 The candidature of the following 02 candidates (UR-01, PH(OH)OL-01) has been kept still pending since candidates have not uploaded requisite documents in the e-dossier during the stipulated time period between 24.07.2020 to 02.08.2020, accordingly, their candidature kept pending due to reasons mentioned below in the remarks column:-

6. The above pending 02 candidates (UR-01, PH(OH)OL-01) are being given 2nd and final opportunity to upload their pending/all requisite/applicable documents through the e-dossier link on OARS module of the Board within stipulated time. The e-dossier link shall be active from 04/09/2020 to 08/09/2020, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground. The above candidates are also being separately informed through SMS on their registered mobile number as additional facility.
7. The selection of the above 02 candidates (OBC-02) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
8. The Selection of the above 02 candidates (OBC-02) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

9. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Delhi Jal Board, GNCTD shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
 11. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
 12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
 13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
 14. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
 15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
 16. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
