## SUPPLEMENTARY RESULT NOTICE NO: 711 DATED 19.11.2020

### DRAWING TEACHER, POST CODE-208/14 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 02/14 dated 12/12/14 had advertised total **202** [UR-83, OBC-44, SC-08, ST-67 including PH/OH-02, PH/HH-02] vacancies for the post of **Drawing Teacher, Post Code-208/14 in Directorate of Education** with closing date as 25.01.2015. Tier-I examination in offline written examination mode was conducted on **30.04.2017**.

2. On the basis of offline examination of Tier-1 held on **30.04.2017** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/2014 and RRs for the post of **Drawing Teacher, Post Code-208** in Directorate of Education, **97 Candidate (UR-71, OBC-11, SC-08, ST-07 including PH)** were provisionally selected for the post of **Drawing Teacher, Post Code-208/14 in Directorate of Education** vide Result Notice No. **212** dated 10.11.2017 and the candidature of **18 candidates** were kept pending for want of deficient documents. However, after declaration of result, some of the candidates had approached the User Department i.e. Directorate of Education for considering their BFA qualification as equivalent to B.A. (Hons.) in Art & Art Education and thereby making them eligible for the post of Drawing Teacher within the ambit of the Recruitment Rule. After considering the representations of the candidates, the Directorate of Education had intimated that candidates having 04 years BFA qualification are to be considered to be having B.A. (Hons.) in Art & Art Education as per the judgment of Hon'ble High Court of Delhi in W.P. (C) No. 7263/2007 in the matter of Nirmala & Ors. Vs. GNCTD.

3. Accordingly, the result notice no. 212 dated 10.11.2017 was modified in accordance with clarification received from the user department vide letter dated 03.05.2018 and therefore, a total of **117 (UR-71, OBC-21, SC-07, ST-18 including PH)** were provisionally nominated vide Revised Result Notice No. 251 dated 24.05.2018. Further, candidature of 21 candidates was withdrawn due to modification of result notice no. 212 dated 10.11.2017.

4. Further, aggrieved by the withdrawal of the candidature, some of the candidates filed court case in the Hon'ble CAT and the Hon'ble CAT in O.A. No. 2369/2018 with O.A. No. 1490/2019 in the matter of Yogesh Kumar & Ors Vs. Govt. of GNCTD & Ors. has decided the matter with the observation that "*the candidates already appointed on the basis of the result as declared on 10.11.2017, shall not be disturbed in any manner on account of second select list of 24.05.2018. The other candidates, who were selected on 24.05.2018, shall also be given offer of appointment, if other conditions are satisfied by those candidates*". Therefore, in compliance of the directions of the Hon'ble CAT in O.A. No. 2369/2018 with O.A. No. 1490/2019 in the matter of Yogesh Kumar & Ors Vs. Govt. of GNCTD & Ors. A combined merit list of UR category & SC category has been forwarded to the user department. However, 07 vacancies

which had been kept pending for want of deficient documents in the e-dossier were given final opportunity to upload the deficient documents in the dossier and they were given an opportunity to upload the deficient documents in the e-dossier w.e.f. 14/07/2020 to 18/07/2020. Further, out of 07 pending candidates whose candidature was kept pending for want of deficient documents, 04 candidates have uploaded the requisite documents and found eligible as per RRs and provisionally nominated vide Supplementary Result Notice no. 680 dated 09.10.2020. The candidature of 03 candidates were kept pending. The pending candidates were given 2<sup>nd</sup> and final opportunity w.e.f. 13.10.2020 to 17.10.2020 vide notice dated 09.10.2020. Out of these 03 candidates, only 01 candidate has uploaded the requisite/deficient documents in the e-dossier. 02 candidates who failed to upload their deficient / requisite documents in the-dossier, have been rejected.

5. Accordingly, in continuation to Result Notice No. 251 dated 24.05.2018, Result Notice No. 318 dated 14.12.2018, Supplementary Result Notice No. 680 dated 09.10.2020, the candidate, as detailed below, is also provisionally selected on the basis of offline examination of Tier-1 held on 30.04.2017 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.02/14 and RRs for the post of **Drawing Teacher, Post Code-208/14** in Directorate of Education, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in the offline application forms and e-dossier:-

6. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of her identity with reference to her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority



shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

11. **The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.**

12. The result process for the above post code stands closed in all respect.

13. A waiting panel which was valid for a one year from the date of declaration of result has already been expired on 09.11.2018.

14. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

15. The category wise marks obtained by the last selected candidates have been given as under:-
