Reference Notice No. F. No. 271/Result/PGT (Maths)/Female/CC-III/DSSSB/2021-22/1218-26 dated 23.9.2021, the shortlisted candidates for the post of PGT (Maths) Female, post code-29/20 were asked to upload their documents in the e-dossier w.e.f. 28.09.2021 to 12.10.2021.

2. On scrutiny of the documents in the e-dossier, it has been noticed that 02 candidates have uploaded their e-dossier with deficient documents and accordingly, their candidature has been kept pending for want of deficient / requisite documents in the e-dossier. 1<sup>st</sup> opportunity was given to upload the deficient /requisite documents for period of 10 days w.e.f. 29.10.2021 to 07.11.2021. 01 candidate uploaded deficient /requisite documents. Therefore, the candidate detailed given below is being given 2<sup>nd</sup> and final opportunity w.e.f. 26/11/2021 to 30/11/2021 to upload the deficient /requisite documents as mentioned against their roll number, in the e-dossier:-

Hence, the candidate is directed to upload marks sheet/clarification mentioning passing date of M.SC (Maths) in e-dossier. The candidate should ensure that she fulfills all the eligibility criteria as on the cutoff date i.e. 13.02.2020.

3. The above 01 candidate is being given 2<sup>nd</sup> and final opportunity w.e.f. 26/11/2021 to 30/11/2021.

**4. The e-dossier link shall be activated to the above 01 pending candidate only for a period of 05 days w.e.f. 26/11/2021 to 30/11/2021.**

5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 13.02.2020 as per Advertisement No. 02/2020.

6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions.
