UNDER POST CODE 45/12 IN NDMC.

1. The DSSSB vide its advertisement No.02/2012 had advertised **16 vacancies (UR-10, OBC-04, SC-02 including PH-VH-LV-01)** for the post of **Data Entry Operator Grade-"B"** under **Post Code 45/12 in NDMC.**
2. The written examination (online mode) was conducted on **22.11.2019.**
3. The normalized marks obtained by **533 candidates** who have duly appeared in written examination held on 22.11.2019 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
4. Based on the performance in the Tier-I written examination (online Mode), a total of **66 candidates who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Skill Test(Data Entry),** subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

5. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in skill test (Data entry) does not entitle them any right over the post.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.
7. Further, all the candidates who have scored marks equal to the cut off marks in each category have been shortlisted.
8. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examination for UR Category Candidate is 40% for OBC candidate is 35% for SC/ST/PH candidate is 30%

9. The details of skill test (Data entry) shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.

10. The above short-listing for skill test (Data entry) for the post of Data Entry Operator Grade-"B" under Post Code 45/12 in NDMC will be subject to outcome of pending court cases, if any.

11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
