1. The DSSSB vide its advertisement No.01/2019 had advertised **total 61 vacancies (UR-08, OBC-45, SC-02, ST-06 including PH-OH-03, PH-HH-03, PH-AIDSLDMI-02, EXSM-06, SP-02)** for the post of **Junior Engineer (Civil) under Post Code 06/19 in DUSIB.**
2. The written examination (online mode) was conducted on **Nov. 5th & 6th, 2019.**
3. The normalized marks obtained by **5052 candidates** who have duly appeared in written examination held on **Nov. 5th & 6th, 2019** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
4. Based on the performance in the Tier-I written examination (online Mode), a **total of 361 candidates who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination,** subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.
7. Further, all the candidates who have scored marks equal to the cut off marks in each category have also been shortlisted.

8. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in one Tier written examination for UR Category Candidate is 40%, for OBC candidate is 35% and for SC/ST/PH candidate is 30%
9. **The details of Tier-II examination shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.**
10. The above short-listing for Tier-II Exam for the post of Junior Engineer (Civil) under Post Code-06/19 in DUSIB will be subject to outcome of pending court cases, if any.
11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
