ASSISTANT GRADE-III, POST CODE-57/13 IN DELHI TRANSCO LIMITED.

The DSSSB vide its advertisement No. 03/2013 dated 12/09/2013 had advertised total 38 [UR-02, OBC-27, ST-09 including 01 PH(OH)] vacancies for the post of Assistant Grade-III, Post Code-57/13 in Delhi Transco Limited with closing date as 18.10.2013. Tier-I offline written examination was conducted on 24/09/2017. Further, as per Recruitment Rules and clarification provided by the user department, a computer based skill test of the qualified shortlisted candidates was held on 04.01.2019, 05.01.2019 & 06.01.2019.

- 2. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following 29 Candidates (UR-01, UR/PH (OH)-01, OBC-23, ST-04) were provisionally selected vide Result Notice No. 546 dated 25.11.2019 for the post of Assistant Grade-III, Post Code-57/13 in Delhi Transco Limited. However, 09 vacancies (OBC-04, ST-05) were remained unfilled even after considering all the qualified candidates who qualified the skill test held on 04.01.2019, 05.01.2019 & 06.01.2019. Therefore, the candidates below the merit of last selected candidate were shortlisted for appearing in the skill test (typing test) vide notice dated 18/12/2019. The skill test (typing test) was held on 04.01.2020.
- 3. Accordingly, in continuation of Result Notice No. 546 dated 25.11.2019, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 24.09.2017 & skill test held on 04.01.2020 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.03/13 and RRs for the post of Assistant Grade-III, Post Code-57/13 in Delhi Transco Limited subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

4. It is highlighted that besides Graduation as essential qualification, the candidate must have knowledge of computer operation including complete knowledge of MS office. In order to

judge the second part regarding computer knowledge, related questions have already been included in the T-I examination. However, the user department may check this aspect at their level.

- 5. The selection of the above 08 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No.

36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.

- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The candidature of 01 candidate as per details given below is being kept pending for want of deficient /requisite documents in the e-dossier. The candidate is given 10 days 1st opportunity w.e.f. 22/10/2020 to 31/10/2020, failing which his candidature will be rejected and no further opportunity will be given on whatsoever ground:-

- 12. The e-dossier link for the above pending candidate shall be activated w.e.f. 22/10/2020 to 31/10/2020.
- 13. The recruitment process for post code-57/13 is closed in all respect except 01 pending case as referred above at para-11.
- 14. The main result for the post of Asstt. Grade-III, post code-57/13 was declared on 25.11.2019 vide result notice No. 546 dated 25.11.2019. The waiting panel is valid for a period of one year from the date of declaration of result i.e. upto 24.11.2020 as per earlier result notice No. 546 dated 25.11.2019
