ORDER

Reference is drawn to the orders passed by the Hon'ble CAT in O.A. No. 1243/2019 dated 23.4.2019 wherein the court had directed the Board/Respondent to examine the representation dated 3.4.2019 and 15.4.2019 filed by applicant Sh Jai Kumar .

Having gone through the contents of representation, it is evident that the applicant had failed to upload his e dossier within stipulated time limit because of some demise in his family. In this context it is to bring to notice even in the admit card and notice uploaded on website of board it was amply made clear that if the e- dossier is not uploaded within stipulated time period, it will not be accepted and the details of text as mentioned in e- dossier notice is reproduced as under :-

***If any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e dossier will be given on whatsoever grounds.***

Further, in a similar matter the Division Bench of the Hon'ble High Court has rejected the contention of applicant in WPC No. 4085/2019 and C.M. No. 18419/2019 dated 22.4.2019 titled Ms. Jyoti V/s GNCTD & Ans. wherein while upholding the orders of Ld. CAT in OA No. 800/2019 dated 19/3/2019, the Hon'ble High Court has observed as follows :-

***.....The Tribunal has found and we agree with the said findings, that if the petitioner is permitted to upload her e dossier after the closing of the scheduled period, the same would amount to discrimination against others, who may have similarly not been able to upload their e -dossiers by the notified date.... Merely because the petitioner claims that she was pregnant or out of town is no ground for extension of time as the selection process which is undertaken on a very large scale, cannot be delayed or withheld on account of the circumstances of a particular candidate.***

Accordingly, the representation made by the applicant Sh Jai Kumar is neither covered by the policy of the Board nor the same is legally tenable, in view of the aforementioned judgment passed by the Hon'ble High Court, Delhi and accordingly the request made by the applicant cannot be acceded to.
