1. The DSSSB vide its advertisement no. 02/2012 with closing date 15/06/2012 had advertised 06 vacancies (UR-03, OBC-02 & SC-01) for the Post of Assistant Architect under post code 39/12 in MCD. Board Conducted Tier-I (T) written examination for recruitment in respect of this post on 12/10/2019.

2. The marks statement of the candidates has been uploaded on OARS Module of the Board for information of the candidates. All the candidates can view their marks by logging into their account in the OARS Module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in).

3. Based on the performance in Tier-I written examination, 02 candidates as detailed below, have been provisionally shortlisted to appear in Tier-II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitle them any right over the post.

5. Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.

6. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in One Tier written examination for UR category candidate is 40%, for OBC candidate is 35% and for SC/ST/PH is 30%.

7. 02 (UR-01 & SC-01) candidates who are qualified in Tier-I examination have been shortlisted for appearing in Tier-II examination.

8. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
