**REJECTION NOTICE - 588**

**B.A.B.T. Teacher (for blinds), Post Code-44/12 in Department of Social Welfare.**

Whereas it is stated that all candidates who appeared in the examination held on 03.11.2019 for the post of **B.A.B.T. Teacher (for blinds), Post Code-44/12 in Department of Social Welfare** were given clear instructions on Question Booklet as well as on OMR answer sheet including the following direction:-

a). The candidates were informed as per the instructions stipulated at Sl. No. 2 of question booklet for the post code-44/12 that - **"The candidate must complete the details of Roll Numbers, Question Booklet No., etc, on the Answer sheet and Answer Sheet No. on the space provided above in this Question Booklet, before he/she actually start answering the questions, failing which Answer-sheet will not be evaluated and he/she will be awarded 'Zero' marks"**.

b). As per the instructions stipulated at Sl. No. 3 of question booklet for the post code-44/12 that - **"A machine will read the coded information in the OMR Answer sheet. In case Non/wrong bubbling of Roll Number etc., the machine shall reject such OMR answer sheet and hence such OMR answer sheet shall not be evaluated.**

c). As per the instructions stipulated at Sl. No. 5 of OMR answer sheet for the post code-44/12 that - **"Valuation of answer sheet will be done on the computer. Candidate should not take any stray marks on the Answer Sheet, tamper with or mutilate it. Otherwise it will not be evaluated"**.

d). As per the instructions stipulated at Sl. No. 6 of OMR answer sheet for the post code-44/12 that - **"The appropriate circle should be shaded for Roll Number, Question Booklet No. and Preference of Post codes applied for etc. This should be done carefully because only the shaded circle is scanned"**.

2. It is further informed that the Board has been following automated system of reading Roll No. etc., on OMR answer sheet through scanner without any manual intervention. Further, the automated system/scanner did not identify the Roll No. on OMR answer sheet in respect of 01 (One) candidate who appeared in the examination held on 03.11.2019 for the post of **B.A.B.T. Teacher (for blinds) under post code-44/12 in Department of Social Welfare** due to wrong bubbling of Roll Number in OMR answer sheet by the respective candidate. Hence, their question booklet/OMR Answer sheets could not be evaluated as per detail given below:-
