- Mere asking the candidate for uploading deficient/ requisite documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient /requisite documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
