ORDER

This order shall dispose of the representation dated 06.01.2022 filed by Ms. Meenakshi (Roll No. 3350551000055), a candidate for the post of TGT (Sanskrit (Female) under Post Code – 55/21 in Directorate of Education in compliance of the directions of Hon'ble Central Administrative Tribunal order dated 30.03.2022 in OA No. 526/2022, in the matter of Ms. Meenakshi V/s GNCTD & Ors.

- 2. The Hon'ble Tribunal vide its Order dated 30.03.2022 in the O.A. No. 526/2022 titled as Meenakshi VS GNCTD & Ors., has given the following direction:
 - "6 Keeping in view the above facts and circumstances of the case, without expressing any opinion on merits of the case, we direct the respondents to decide the representation dated 06.01.2022 made by the applicant within a period of one month from the date of receipt of a copy of this order, by passing a reasoned and speaking order
 - 7. with the above directions, the OA stands disposed of . There shall be no order as to costs."

3. Brief facts of the case

As per requisitions received from the Directorate of Education, the DSSSB advertised the total 1159 vacancies (206 vacancies for SC category) vide its advertisement for the post of TGT Sanskrit (Female), under Post Code 55/21.

4. As per the DSSSB Notice dated 26/04/2013, the minimum Qualifying Marks in written examination for different categories are as under:-

UR: - 40%

OBC: - 35%

SC/ST/PH: - 30%

EXSM: - Will be given 5% relaxation in their respective categories subject to a minimum of 30%.

5. As per the Examination Scheme, the selection shall be made through one Tier Technical examination comprising Section-A (100 marks) and Section-B (100 marks). The merit has been prepared on the basis of aggregate marks of both the sections A & B, i.e. out of 200 marks. Further in the 'NOTE' below Annexure-V at Point (i), it is clearly mentioned that candidate have toqualify separately Section A & B as per their category minimum qualifying marks. The Point (i) is reproduced below:

"Applicants of Post Code 49/21 to 57/21 must have to qualify in Section A & B separately as per their category's (UR/OBC/SC/ST/Ex-SM) minimum qualifying marks. However, final merit will be prepared on the baiss of aggregate marks of both the section A &B."

6. In compliance of order dated 30.03.2022 in the O.A. No. 526/2022 titled as Meenakshi VS GNCTD & Ors., the case of applicant has been examined and it has been found that the applicant in O.A., Ms. Meenakshi (Roll No. 3350551000055) applied for the Post of TGT Sanskrit (Female) under Post Code 55/21. Detail of Ms. Meenakshi is as under:

- 7. DSSSB declared the category-wise marks of candidates vide Notice No. 1336 dated 05.01.2022, and candidates were directed to upload e-dossiers. Cut off marks for uploading of e-dossier for SC category was 60.47 marks. Applicant obtained total 86.33 marks, but she was not shortlisted for uploading of e-dossiers as she could not obtain minimum qualifying marks in Section-A of Written Examination. Minimum qualifying marks for SC category candidates is 30% (i.e. out of 100 marks in Section A) and Ms. Meenakshi obtained 28.28 marks out of 100.
- 8. Applicant filed OA No. 526/2022, titled as Ms. Meenakshi V/s GNCTD & Ors. Ld. Tribunal vide its order dated 30.03.2022 has directed to decide the representation dated 06.01.2022 (copy thereof annexed as Annexure 4 in the said O.A.) of Ms. Meenakshi. The applicant vide her representation dated 06.01.2022 has stated as under:-
 - "2. On 05.01.2022 result was announced and I scored total 86.33 marks (Section A marks: 28.28 and Section B marks: 58.05 and was not short listed.
 - 3. As per your Annexure-V of goodself advertisement dated 27.05.2021, the marking procedure was for correct answer one mark will be awarded and if wrong 0.25 marks will be negatively awarded.
 - 4. The total question were 100 in Tier-1 (examination (section-A) Need not to say here, as per above marking procedure of your goodself, I can \get the marks as follows- (a) For each correct answer, I will get 01 (One Mark), and (b) For each wrong answer, I will get 0.25 i.e. 0.25, 0.50, 0.75 and full marks as one. But it was awarded after decimal point as 028. (c) On the observation of my result which is annexed in para 2 above, my marks in Section-A of Tier are 28.28 which is not in the multiple of 0.25 and it seems to be totally incorrect and which cannot be possible in any way"
- 9. Vide the representation dated 06.01.2022, the Applicant has taken plea that negative marks are awarded in the multiple of 0.25 i.e. 0.25, 0.50, 0.75 and full marks as one and therefore it is not possible that marks as 0.28 be awarded (as 28.28 in section A).



- 10. In this regard it is stated that vacancies for the Post of TGT (Sanskrit) Female under Post Code 55/21, were advertised vide Advertisement No. 03/21 dated 27.05.2021. According to the Advertisement the Examination for the Post Code 55/21 was One-Tier-Technical having Section-A (100 marks) & Section-B (100 marks). According to Examination Scheme candidates must have to qualify in Section A & B separately as per their respective category (UR/OBC/SC/ST/Ex-SM) minimum qualifying marks.
- 11. Ms. Meenakshi was not shortlisted for uploading of e-dossier as she did not obtained qualifying marks in Section A of Examination as per requirement of Examination Scheme.
- 12. According to Advertisement 03/21 dated 27.05.2021 (Note: (i) Annexure-V) applicants must have to qualify in Section A & B separately as per their category's (UR/OBC/SC/ST/Ex-SM) minimum qualifying marks.
- 13. At Point 3. Note (iv), it has clearly been mentioned that the "The Board the minimum qualifying marks for different (UR/OBC/SC/ST/P.W.D./Ex-SM) vide Notice No. F.4 (130)/P&P/13/DSSSB/20-33 dated 26.4.13, in order to achieve qualitative selection and to recruit the best talent available and the same is available on the website of the Board". According to said Notice dated 26.04.13, the minimum qualifying marks for SC category are 30%. Exam was conducted on 18 and 26th September 2021. There was 01 invalid question on 18 September 2021 shift and 03 invalid questions were on 26th September 2021 shift. Thus prorated marks were awarded to all candidates for invalid questions. Thereafter, marks were normalized as per standard formula. The fraction of marks appearing for Section A and Section B is due to award of prorated marks to candidates for invalid questions and thereafter normalization of these marks for two shifts. The Applicant's marks (normalized marks) in Section A is 28.28 out of 100 marks, which is less than 30 % marks. The raw marks of applicant in Section A are 28 out of 100 which are even lesser than 28.28 marks.
- 14. As regards awarding of marks in non-multiple of 0.25 i.e. 0.25, 0.50, 0.75 and full marks as one, it is submitted that DSSSB declares normalized marks and not raw marks. Normalized marks can be non-multiple of 0.25. Most of candidates are having marks in non-multiple of 0.25 marks. The minimum qualifying marks declared vide Notice No. 1336 dated 05.01.2022 for various categories for uploading of e-dossier were also non-multiple of 0.25.



Normalization of marks is done with a notified formula and it is applied when examination is held in multiple shifts (Annexure-1).

- 15. In view of above, the applicant could not be shortlisted for uploading of edossiers or further selection under Post Code 55/21 for the Post of TGT (Sanskrit) Female, which is justified and in accordance with Examination Scheme. The status of candidature of applicant Ms. Meenakshi (Roll No. 335055100005) remains same i.e. Not-shortlisted for uploading of e-dossier or not shortlisted for any further consideration for the post TGT (Sanskrit) under Post Code 55/21.
- 16. This issues with the approval of Competent Authority and in compliance of order dated 30.03.2022 of Ld. Central Administrative Tribunal passed in OA No. 526/2022, titled as Ms. Meenakshi V/s GNCTD & Ors.
