### ORDER

This order shall dispose of the representation dated 18/12/2021 filed by Sh. Jitender Rathee (Roll No. 11260205349), a candidate for the post of Grade-IV DASS, Post Code-02/17 in Services Department in compliance of the directions of Hon'ble Central Administrative Tribunal order dated 08.04.2022 in OA No. 907/2022, in the matter of Jitender Rathee V/s Govt. of NCT of Delhi and Ors.

- 2. The Hon'ble Tribunal while disposing the Original Application No. 907/2022 has directed to the respondents to decide the pending representation dated 18/12/2021 of the applicant within a period of eight weeks from the receipt of a copy of the said order. Copy of the representation is found annexed with O.A. as Annexure A-1. The applicant vide his representation dated 08.04.2022 has prayed as under:-
  - "5. That I was running pillar to post and as advice I filed application dated 05.08.21 under Delhi Right to information Act 2001 and in response as 22.09.21 I received the Rules/Formula under which cut of the typing test has been issued i.e. Total strokes/5= total word, Net speed = Total word-mistakes with penalty/time and 30.11.21 I received the copy of my typing sheet, typed during test held on 26.12.19 with evaluation sheet. That shows that I made 27 errors and in second para first line one word i.e. missing whereas in facts no such word was there to be typed in the question sheet which was provided to me for typing there are also the discrepancies found in the result sheet/typing sheet which should be removed. If that so called missing word i.e. not missing in my typing sheet than my total mistake were reduced to 18 and as per the formula speed will be increased to 40 word per minute and that qualified me in typing test and I become entitled for the said appointment."
- 3. Vide Point No. 6 of his representation the applicant has claimed that he has typed more than 2000 words with more than 95 % accuracy.



#### Brief facts of the case

4. As per requisition received from the Services Department, the DSSSB advertised 842 vacancies (400 for UR category) for the Post of Grade-IV (DASS)/Jr. Assistant in Services Department vide Advertisement No. 01/17 dated 18.07.2017.

# 5. Qualifications:-

#### Essential:-

- 1. 12<sup>th</sup> Pass or equivalent qualification from a recognized Board or University.
- 2. Typing Speed of 35 w.p.m in English or 30 w.p.m in Hindi on computer (35 w.p.m in English or 30 w.p.m correspond to 10500 KDPH/9000 KDPH on average of 05 key depressions for each word).
- 6. The applicant in O.A., Sh. Jitender Rathee had applied for the Post of Grade-IV (DASS) under Post Code 2/17, but could not qualify the skill test/typing test. His detail is as under:

7. As stated above, the applicant has filed OA No. 907/2022, titled as Jitender Rathee V/s Govt. of NCT of Delhi and Ors. and Ld. Tribunal vide its order dated 08.04.2022 has directed to decide the representation dated 18/12/2021. In compliance of said order dated 08.04.2022 of Ld. Tribunal, matter has been examined and it has been found that Sh. Jitender Rathee (Roll No. 11260205349) was shortlisted for Skill Test/Typing Test vide Notice No. 867 dated 19.12.2019 on the basis of marks obtained in written test. Sh. Jitender Rathee appeared in Skill Test conducted on 26.12.2019. A copy of Typing passage is annexed as Annexure-A and copy of

evaluated typing sheet of applicant is annexed as Annexure-B. Following is stated on the basis of Skill Test/Typing Test Sheet of applicant:

No. of strokes typed:

1978

No. of words typed:

1978/5=395.6

No. of errors (with penalty):

27x2 = 54

Net Speed=

34.16

- 8. As regards, applicants averment vide Point No. 5 of his representation dated 18/12/2021 that there was no word missing in first line of second para, hence his mistakes are 18. In this regard it is submitted that no error was counted for missing word in the first line of  $2^{nd}$  para. In the first line of  $2^{nd}$  para only one error was counted for typing "have" instead of "Have".
- 9. However, the applicant missed to type a full line of 9 words in the  $1^{st}$  Para (in  $3^{rd}$  and  $4^{th}$  line). The said missing line is reproduced below:

## "You must persist through criticism, rejection, pressure and failure."

- 10. Besides the above 09 missing words, 18 other errors were also committed by the applicant in typing test, which are quite evident from the evaluated typing test sheet of applicant. As such the applicant has committed 27 errors in his typing test.
- 11. As regards applicant's averment in Point No. 6 of representation that he typed more than 2000 words, it is stated that he typed only 1978 strokes or 395.6 words. Skilll test/typing sheet has been signed by the applicant himself at the end of typing test. Therefore, the evaluation and calculation of typing speed of Sh. Jitender Rathee is absolutely correct i.e. 34.16 w.p.m. The minimum speed for qualifying the typing test/skill test was 35 w.p.m. in English for the Post of Grade-IV DASS under Post Code 02/17.
- 12. In view of above, the applicant could not qualify the skill test/typing test, therefore his candidature was not processed further and his name was not included in the Notice No. 1043 dated 08.09.2020 issued for declaration of Roll Numbers of candidates who qualified the skill test for the post of Grade-IV DASS/Jr. Assistant under Post Code 02/17. Hence, status of candidature of applicant Sh. Jitender Rathee (Roll No. 11260205349) remains same i.e. unselected being un-qualified in skill test/typing test.
- 13. This issues with the approval of Competent Authority and in compliance of the directions of Hon'ble Tribunal.
- 14. Let this order be served upon Sh. Jitender Rathee (Roll No. 11260205349), S/o. Dharmander Singh, having in post code 02/17, Grade-IV DASS, R/o R/o VPO-Parnala,
