- The DSSSB vide its advertisement No. 01/2014 had advertised 06 vacancies (UR-03, OBC-02, SC-01 including EXSM-01) for the post of Instructor (Mill Wright) under Post Code-107/14 in Directorate of Training and Technical Education, GNCTD.
- 2. The written examination (Offline Mode) was conducted on 09.11.2019.
- 3. The marks obtained by **24 candidates** who have duly appeared in written examination held on **09.11.2019** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 4. Based on the performance in the examination, the candidates who have secured equal and more marks in their respective category as per details given below are being provisionally shortlisted and accordingly allowed to upload e-dossiers subject to correctness of the information furnished by the candidates in their online application forms:

- 5. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional/Experience Certificate/Degree / Mark sheets/Caste certificate/Disability certificate/Proof of Govt. Servant/Ex. Serviceman/Admit Cards etc., as applicable in the e-dossier module in OARS link in their individual account. Shortlisting is being made on the basis of marks obtained in offline examination held on 09.11.19.
- 6. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossiers as per details given in para 4 above.
- 7. The e-dossier link shall be active from 31.01.2020 to 14.02.2020. The candidate while uploading e-dossier should ensure that he/she fulfils all the eligibility criteria/all essential qualifications as per RRs for the post as on the cut-off date i.e. 27.02.2014.
- 8. The above shortlisted candidates are also being separately informed through SMS and E-mail on their registered mobile number and E-mail Id as an additional facility only. If, any candidate fails to upload e-dossier during the above said period his/her candidature shall be rejected and no further opportunity will be given on whatsoever ground.



- 9. All the candidates who have been shortlisted for uploading e-dossiers **MUST** upload their all requisite / applicable documents in the said link in **stipulated time i.e. 31.01.2020 to 14.02.2020**.
- 10. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate fulfils all the required eligibility criteria. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 11. The above Shortlisting of candidates for calling of e-dossiers for the post code-107/14 will be subject to outcome of pending court cases, if any.
- 12. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
