## NOTICE

In compliance of the Order dated 21.04.2022 in WP(C) No. 573/2020 in the matter of Anju Gehlawat vs GNCTD & Ors, passed by the Hon'ble High Court of Delhi, the E-Dossier of the candidate bearing Roll No. 2640005575 under OBC Category is called, subject to attaining the minimum qualifying marks and correctness of the information furnished by the candidate in his/her application form for the post of Assistant Teacher (Nursery), Post code-88/17.

- 2. The above mentioned candidate is hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module.
- 3. The link for uploading of e-dossier shall be kept open for a period of 15 days <u>w.e.f.</u> 20.05.2022 to 03.06.2022 only for the above candidate, failing which his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 4. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e., 31/01/2018. The shortlisted candidate is also being separately informed through SMS & E-Mail on his/her registered mobile number & e-mail id as additional facility. If, any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 5. THE LINK FOR UPLOADING OF E-DOSSIER SHALL BE OPENED ONLY FOR THE ABOVE SHORTLISTED CANDIDATE UNDER OBC CATEGORY W.E.F. 20.05.2022 to 03.06.2022.
- 6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 7. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
