1. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **PGT (Hindi), Female, Post Code-69/20** in **Directorate of Education** and the terms and conditions of the advertisement, the candidature of 02 candidate in respect of the above said post code is rejected for the reason/ remarks mentioned against her roll number:-

2. **UR CATEGORY:-**

1	112006900521	B. Ed. Not done. As the candidate had not uploaded B.Ed. degree & its marks sheets in the e-dossier, she was given two opportunities w.e.f. 08/11/2021 to 17/11/2021 & 30/11/2021 to 04/12/2021 but she failed to upload B.Ed. degree and its marks sheet. However, this condition was releasable that in case, the candidate has not done B.Ed., then a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). But she has also not uploaded any declaration in the e-dossier. Hence, her candidature is rejected for not having B.Ed. degree as per RRs.
2	111806900118	The candidate has done B.Ed. after cutoff date i.e. December, 2020 However, this condition was releasable that in case, the candidate has not done B.Ed., then a Self declaration certificate that the candidate will acquire the B.Ed. or B.T qualification within a period not exceeding three years from the date of his or her joining the service (in case the candidate having First Division in Higher Secondary, Degree and Post Graduate examination and not having Bachelor Degree in Education). But as per documents uploaded by the candidate in the e-dossier, it has been found that she has second division in Graduation. Hence, this condition is not applicable to her and accordingly, she was given two opportunities w.e.f 10.12.2021 to 19.12.2021 & 22.12.2021 to 26.12.2021 to upload B.Ed. as on cutoff date but she failed to upload the deficient / requisite documents in the e-dossier. Hence, her candidature is rejected for fulfilling the eligibility criteria as per RRs.
