Candidates for the post of Assistant Teacher Nursery, Post Code-43/21 and uploading e-dossier – regarding.

Reference Notice No. F. No. 297/Result/Assistant Teacher (Nursery)/CC-III/DSSSB/2021-22/159-167 dated 12/01/2022, the shortlisted candidates for the post of Assistant Teacher (Nursery), post code- 43/21 were asked to upload their documents in the e-dossier w.e.f. 14/01/2022 to 28/01/2022.

2. Further, 74 Candidates with deficient documents, were given 1<sup>st</sup> opportunity w.e.f. 14/03/2022 to 23/03/2022 to upload the deficient /requisite documents. However, out of 74 candidates, 03 Candidate have not uploaded the requisite documents. Therefore these 03 Candidates are being given 2<sup>nd</sup> & final opportunity w.e.f. 13/05/2022 to 17/05/2022, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground.

3.	327043100056	As per RR, the candidate must have passed Hindi at Secondary Level, However she has not studied Hindi subject at Secondary Level the candidate is directed to upload documents mentioning that she has studied Hindi subject at Secondary Level
