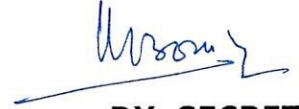

5. **Mere asking the candidate for uploading the deficient documents in the e-dossier module does not confer any right to selection to the applied post.** Final selection will be made purely on the basis of merit against the notified vacancies, provided the candidate falling in the zone of consideration, fulfils all the required eligibility conditions. 6. **While every care has been taken in preparing the above notice, DSSSB reserves the right to rectify errors and omissions, if any, detected at any stage or arising due to court cases.**



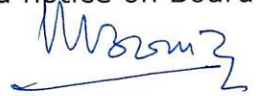
