## TGT (URDU) FEMALE, POST CODE-53/21 IN DIRECTORATE OF EDUCATION.

1. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **TGT (Urdu)**, **Female**, **Post Code-53/21** in **Directorate of Education** and the terms and conditions of the advertisement, the candidature of 04 candidates in respect of the above said post code is rejected for the reason/ remarks mentioned against her roll number:-

S. no.	Roll No	Reason/Remarks
1	113905300012	B.A. degree in History (Honors), The candidate has studied Urdu subject in one year in her Graduation whereas as per RRs, the candidate must have studied subject concerned atleast 02 years during the Graduation Course. She was given two opportunities w.e.f. 15.03.2022 to 24.03.2022 & 11.04.2022 to 15.04.2022 but failed to upload sufficient reply in the e-dossier. Hence, not eligible.
2	111505300011	OBC (Outsider). The candidate has uploaded OBC certificate dated 05.02.2019 issued from Uttar Pradesh. She was given two opportunities w.e.f. 15.03.2022 to 24.03.2022 & 11.04.2022 to 15.04.2022 to upload OBC (D) certificate but she failed to upload OBC (D) certificate. Hence, cannot be considered under OBC (Delhi) category. Her candidature cannot be considered under UR category for taking relaxation in marks in Part-I of written examination
3	112005300051	OBC (Outsider). OBC certificate issued on the basis of her sister Naz Majeed resident of Buxer, Bihar. The candidate was given two opportunities w.e.f. 15.03.2022 to 24.03.2022 & 11.04.2022 to 15.04.2022 but she failed to upload OBC (D) certificate in the e-dossier. Hence, cannot be considered under OBC (Delhi) category. Her candidature cannot be considered under UR category for taking relaxation in marks in Part – I of written examination.
4	113305300045	CTET not done as on cutoff date. She has qualified CTET on 09.03.2022 which is after cutoff date. The candidate has admitted that at the time of applying for the post, she had not CTET qualification. Hence, Rejected for having CTET after cutoff date.
