IN DELHI URBAN SHELTER IMPROVEMENT BOARD (DUSIB)

1. The DSSSB vide its advertisement no. 01/21 dated 04/03/2021 with closing date 14/04/2021 had advertised 03 vacancies (UR-03 including OH-01) for the Post of Assistant Director under post code 21/21 in Delhi Urban Shelter Improvement Board (DUSIB).
2. The prorated marks obtained by 504 candidates who duly appeared in written examination held on 20/03/2022 have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module [www.dsssonline.nic.in](http://www.dsssonline.nic.in)
3. Based on the performance in Tier-I written examination (online mode), out of these 504 candidates only 47 (Forty Seven) candidates could qualified (UR-45 and OH-02) as detailed below, and have been provisionally shortlisted to appear in Tier II examination (fixed, 100, as per policy of the Board) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
4. The shortlisted candidates shall be called for Tier-II examination separately

Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies.
7. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in two Tier written examinations for UR Category Candidate is 40% and for PH candidate is 30%.
8. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
