## REJECTION NOTICE NO: 872 DATED 20.06.2022

## TGT (URDU) MALE, POST CODE-52/21 IN DIRECTORATE OF EDUCATION.

1. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **TGT (Urdu)**, **Male**, **Post Code-52/21** in **Directorate of Education** and the terms and conditions of the advertisement, the candidature of 08 candidates in respect of the above said post code is rejected for the reason/ remarks mentioned against their roll number:-

S. No.	Roll No	Reason/Remarks
1	113105200003	Overage.  The candidate is overage by 2 years 21 days. The candidate had uploaded GCT experience certificate w.e.f. 10.02.2018 to 27.04.2018 of 58 days & 17.07.2018 to 31.05.2019 of 187 days. He can be given one year relaxation in age for the period of 17.07.2018 to 31.05.2019 as he had completed 120 days in a particular year i.e. 2018-2019. The period 10.02.2018 to 27.04.2018 having less working days is not applicable. He was given two opportunities w.e.f. 19.04.2022 to 28.04.2022 & 11.05.2022 to 15.05.2022 to upload more experience certificate if available with him but he failed to upload the relevant experience certificate /documents. Hence, after considering only 01 year relaxation in age for the period of 2018-19 as mentioned above, he is still overage by 01 year 21 days. Hence, rejected for being Overage.
2	111105200037	The candidate has uploaded B. Ed. (Special Education) instead of B.Ed. B.Ed. special education is specialized to teach to the disabled students whereas B.Ed. in general is meant for all students except disabled students. The candidate is not eligible.
3	112005200059	The candidate has qualified CTET with 87 marks in relaxed standard and applied as OBC (Outsider) which considered as UR category. Further, he has also uploaded CTET with 97 marks qualified in 09.03.2022 which is after cutoff date. The candidate was given two opportunities w.e.f. 14.03.02022 to 23.03.2022 & 11.05.2022 to 15.05.2022 but failed to upload CTET qualified certificate as on cutoff date. Hence, not eligible for not having CTET qualified certificate as on cutoff date.
4	112505200045	Overage.  The candidate is overage by 04 years 05 months 03 days. He has uploaded contract teacher in MCD & further Assistant Teacher in New Delhi Municipal Council. The experience certificates of MCD & NDMC uploaded by the candidate are not considerable as per DoPT guidelines wherein relaxation in age are applicable only to Central Government Civilian Employees holding civil posts and are not applicable to personnel working in autonomous / statutory bodies, Public Sector undertaking etc. which are governed by regulations /statue issued by the concerned administrative Ministries / Department.

3	11110320003	The candidate is overage by 03 months 27 days even after giving 03 years relaxation in age of OBC ctgy. He has however, uploaded experience certificate as Contract Teacher in MCD which is not considerable as per DoPT guidelines wherein relaxation in age are applicable only to Central Government Civilian Employees holding civil posts and are not applicable to personnel working in autonomous / statutory bodies, Public Sector undertaking etc. which are governed by regulations /statue issued by the concerned administrative Ministries / Department.
6	112505200092	The candidate has qualified CTET with relaxed standard and applied as OBC (Outsider) which considered as UR category. Further, he has also uploaded CTET with 101 marks qualified in 09.03.2022 which is after cutoff date. The candidate was given two opportunities w.e.f. 19.04.02022 to 28.04.2022 & 11.05.2022 to 15.05.2022 but failed to upload CTET qualified certificate as on cutoff date. Hence, not eligible for not having CTET qualified certificate as on cutoff date.
7	112005200067	OBC (Outsider), OBC certificate from West Bengal. He was given two opportunities to upload OBC (D) certificate in the e-dossier w.e.f. 19.04.2022 to 28.04.2022 & 11.05.2022 to 15.05.2022 but failed to upload OBC (D) certificate. His candidature is also not under UR category as he has qualified Part-I of written examination with relaxed standard. Hence, rejected for being OBC (Outsider).
8	111405200019	The candidate has applied under UR/GCT/ PHSC ctgy. but PH certificate not uploaded. The candidate in his representation dated 28.05.2022 alongwith copy of another representation dated 02.07.202 uploaded in Edossier admitted that he does not belong to PH category. Further, he has qualified Part-I of written examination with relaxed standard hence, his candidature cannot be considered under UR category.
