## REJECTION NOTICE NO: 875 DATED 20.06.2022

## TGT (SANSKRIT) MALE, POST CODE-54/21 IN DIRECTORATE OF EDUCATION.

1. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of **TGT (SANSKRIT)**, **Male**, **Post Code-54/21** in **Directorate of Education** and the terms and conditions of the advertisement, the candidature of 11 candidates in respect of the above said post code is rejected for the reason/ remarks mentioned against her roll number:-

| 1      | 121205400747 | The candidate has applied OBC (OS) i.e. UR category and qualified CTET with relaxed standard with 87 marks whereas atleast 90 marks (60% marks) are required to qualify the CTET for UR category candidate. Hence, as no relaxation is applicable to UR category candidate, his candidature is rejected.   |
| 2      | 112705400143 | The candidate has applied OBC (OS) i.e. UR category and qualified CTET with relaxed standard with 88 marks whereas atleast 90 marks (60% marks) are required to qualify the CTET for UR category candidate. Hence, as no relaxation is applicable to UR category candidate, his candidature is rejected.   |
| 3      | 113505400054 | Overage. The candidate is overage by 10 months 18 days. He has applied under PHOB category but not uploaded any supporting documents i.e. PH certificate. He has uploaded an affidavit stating that due to technical error, he had applied PHOB ctgy. inadvertently. But he does not belong to this category. The candidate was directed to upload relevant documents with regard to relaxation in age but failed to upload the same, Hence, rejected for being Overage. |
| 4      | 121205400245 | The candidate has qualified CTET with 86 marks by taking relaxation in marks under OBC ctgy. but applied under UR ctgy. he was given two opportunities w.e.f. 05.04.2022 to 14.04.2022 & 26.04.2022 to 30.04.2022 for giving CTET certificate without relaxed standard but he failed to upload the same. Hence, his candidature cannot be considered under UR ctgy. nor OBC cty. as he has applied under UR ctgy.  |
| 5      | 121205400819 | The candidate has qualified CTET with 85 marks by taking relaxation in marks under OBC ctgy. but applied under OBC (OS) ctgy. he was given two opportunities w.e.f. 05.04.2022 to 14.04.2022 & 26.04.2022 to 30.04.2022 for giving CTET certificate without relaxed standard but he failed to upload the same. Hence, his candidature cannot be considered under UR ctgy. nor OBC ctgy for being OBC (OS).   |
| 6      | 121105400001 | The candidate is overage by 01 year 8 months 8 days. He has applied under DGS ctgy. however working in western central railway as P/ Man which is not same allied or cadre to the post of TGT (Sanskrit) Hence, rejected for being overage as per Dopt guidelines.   |
| 7      | 121105400733 | The candidate has qualified CTET with 83 marks by taking relaxation in marks under OBC ctgy. but applied under OBC (OS) ctgy. he was given   |

|    |              | two opportunities w.e.f. 13.05.2022 to 22.05.2022 & 27.05.2022 to 31.05.2022 for giving CTET certificate without relaxed standard but he failed to upload the same. Hence, his candidature cannot be considered under UR ctgy. and OBC ctgy for being OBC (OS).  |

| 8  | 111605400129 | OBC (Outsider) OBC certificate issued from Uttar Pradesh which is be acceptable. As the candidate has applied under OBC (D), he was given two opportunities to upload OBC (D) certificate w.e.f. 05.04.2022 to 14.04.2022 & 26.04.2022 to 30.04.2022 but failed to upload the same. His candidature is also not in UR ctgy. as he is taking relaxation in part-I of written examination.   |
| 9  | 112805400164 | The candidate is overage by 09 years 06 months 25 days. However, after giving 05 years relaxation in age being SC category & 01 year relaxation of GCT ctgy, he is still overage by 03 years 06 months 25 days. He was given two opportunities w.e.f. 05.04.2022 to 14.04.2022 & 26.04.2022 to 30.04.2022 and he uploaded one more experience certificate w.e.f. 22.10.2018 to 10.05.2019 (125) days and as the academic session end with 31.03.2022, he has less than 120 days in a particular year, hence not considerable. The candidate is overage and rejected. |
| 10 | 121105400743 | The candidate has applied under UR category (sub-category – PHOB), being PH candidate, he was given two opportunities w.e.f. 05.04.2022 to 14.04.2022 & 26.04.2022 to 30.04.2022 to upload PH certificate. But he did not upload the same. Hence, his candidature has been rejected under PH category and also under UR category as the candidate was declared qualified under PH ctgy only for being qualified in part-I of written examination with relaxed standard under PH category. Hence, the candidature of the candidate is rejected.                       |
| 11 | 111605400249 | OBC certificate issued on the basis of his father resident of Bihar which cannot be acceptable. He was given two opportunities w.e.f. 05.04.2022 to 14.04.2022 & 26.04.2022 to 30.04.2022 but failed to upload the same. His candidature also cannot be considered under UR category for taking relaxation in Part-I of written examination.   |
