As per Vacancy Notice dated 24.09.2019 Advertisement No. 04/19 one of the Essential Qualifications of the post of Fire Operator, Delhi Fire Service, Post Code-18/19 is:"Candidate should possess valid license for driving heavy duty vehicles."

The last date of this vacancy notice was 06.11.2019. Therefore a candidate should has issued Heavy Motor Vehicle (HMV) driving license on or before 06.11.2019 to take Driving Skill Test.

The candidate Muneeraj Meena, Roll No. 7030001077 has produced a HMV driving license issued on 17.03.2019 for Driving Skill Test. On arising doubt his driving license was checked on Sarthi Parivahan, Ministry of Road Transport & Highways, GOI where the said license was issued on 17.03.2020 i.e. after last date of the vacancy notice. The candidate, Mr. MUNEERAJ MEENA has produced a forged driving license for driving skill test whose details are mentioned in table below. Thus he was found indulging in unfair means, malpractices and criminal activity like Forgery, Conspiracy etc. during the above said post code exam.

Thus a case of unfair means, malpractices and criminal activity like Forgery, Conspiracy etc.

Further in the said advertisement under point 08 regarding action against the candidates found guilty of misconduct have been warned not to resort to any unfair means/ malpractices. The same is reproducing as under:-

"Point no. 8. Action against candidates found guilty of misconduct:

Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form. Candidates are also

warned that they should neither attempt to alter or otherwise tamper with any entry in a document or the self attested certified copy submitted by them nor submit a tampered/fabricated document. If there is any inaccuracy or any discrepancy in filling OMR Sheet, their OMR sheets will not be evaluated.

Without prejudice to criminal action/debarment from DSSSB's examination wherever necessary, candidature will be summarily cancelled at any stage of the recruitment in respect of candidates found to have indulged in any of the following:

- (i) Possession of mobile phone & accessories and other electronic gadgets within the premises of the examination centres, whether in use or in switch off mode and on person or otherwise.
- (ii) Involved in malpractices.
- (iii) Using unfair means in the examination hall.
- (iv) Obtaining support for his /her candidature by any means.
- (v) Impersonate/Procuring impersonation by any person.
- (vi) Submitting fabricated documents or documents which have been tampered with.
- (vii) Making statements which are incorrect or false or suppressing material information.
- (viii) Resorting to any other irregular or improper means in connection with his/her candidature for the examination.
- (ix) Misbehaving in any other manner in the examination hall with the Supervisor, Invigilator or Board's representatives.
- (x) Taking away the Answer Sheet with him/her from the examination hall, or passing it on to unauthorized persons during the conduct of the examination.
- (xi) Intimidating or causing bodily harm to the staff employed by the Board for the conduct of examination.
- (xii) To be ineligible for the Examination by not fulfilling the eligibility conditions mentioned in the Notice.
- (xiii) Candidature can also be cancelled at any stage of the recruitment for any other ground which the Board considers to be sufficient cause for cancellation of candidature.

Further, attention is drawn to the point 11 of the "General Instruction" dated 12.05.2022 for candidates for the said post code which is reproduced as under:-

"If any candidate is found using any unfair means, conspiracy, cheating, fraud, forgery, impersonation or any unlawful act he will be debarred from all examination of DSSSB and necessary legal action will be initiated".

Further, this candidate have also indulged in the act of FORGERY and UNLAWFUL ACT by altering the Driving License and produced this document to the examination conducting functionaries with the intent to defraud, as the document produced is materially different from the records available with Sarthi Parivahan, Ministry of Road Transport & Highways, GOI.

Therefore, it is evident that the candidate was actively involved in the **crime related to** forgery, connivance and conspiracy as specified in Indian Penal Code.

In view of above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of forgery, connivance and conspiracy is made out against the candidate.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view the above Mr. MUNEERAJ MEENA S/o Sh. Harsahay Meena having Date of Birth: 15/06/1993 bearing Roll No.: 112900500606 / 7030001077 of Post Code 18/19 is hereby debarred from any examination conducted/to be conducted by the DSSSB for lifetime w.e.f 20/06/2022. Further the

candidature of Mr. MUNEERAJ MEENA will be deemed cancelled if he has appeared in any exam conducted by DSSSB prior to above date.
