certificate etc. Further, the candidature of the candidates who are already in Govt. Service is subject to normal service conditions i.e. NOC/ declaration etc., from their department concerned. The candidature of the candidates is liable to be cancelled by the user department, in case the candidates are found not to be fulfilling the eligibility conditions or due to any other genuine reasons.

The competent authority of the Department concerned shall issue the appointment letters to the candidates only after satisfying its self of their eligibility as laid down in the recruitment rules especially the recognition of University/Institute, subject in degree/ Diploma etc., and on verification of the correctness of the information/ documents as regards age, qualifications, caste certificates etc., as furnished in the application form. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The result has been processed keeping in view the eligibility conditions regarding educational qualifications/ caste certificate as on cut-off date i.e. 30.07.2010.

For admissibility of benefit of reservation the result has been processed as per the judgment dated 04.08.2009 of Hon'ble Supreme Court of India as passed in Civil Appeal No. 5092/09 (arising out of SLP Civil No. 24327 of 2005) – Subhash Chandra Ors. V/s DSSSB & Ors, with WP (C) No. 507 of 2006 – Sarv Rural & Urban Welfare Society V/s Union of India & Ors.

The user department shall also get the OBC/SC certificate verified from the Issuing Authority before their appointment. Further, it may also be verified that the candidate does not belong to the persons/sections (Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res.) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt(Res.) dated 14.10.2008.
