Uploading of e-dossier for the Post Assistant Teacher (Nursery), Post Code-

43/21 - regarding.

Reference: Notice No. F. No. 297/Result/ Assistant Teacher (Nursery)/CC-III/DSSSB/2021-22/159-167 dated 12.01.2022.

In continuation of this Board's Notice No. F. No. 297/Result/ Assistant Teacher (Nursery)/CC-III/DSSSB/2021-22/159-167 dated 12.01.2022 wherein the candidates were shortlisted for uploading of e-dossier for the post of Assistant Teacher (Nursery), Post Code-43/21 in Directorate of Education w.e.f. 14/01/2022 to 28/01/2022.

- 2. On the basis of documents in the e-dossier uploaded by the shortlisted candidates, the result of eligible candidates has been declared vide Main Result Notice No. 877 dated 24.06.2022 and out of 74 vacancies (UR-46, EWS-08, OBC-08, SC-09, ST-03, including Pwd-04), a total of 70 vacancies (UR-46, EWS-04, OBC-08, SC-09, ST-03, including Pwd-04) have been filled up and 04 vacancies under EWS category still remain unfilled. However, the qualified candidates under EWS category were shortlisted earlier upto the cutoff marks 99.97 marks which have been exhausted / considered for nomination as per their eligibility for the above post code.
- 3. Further, in partial modification at para-26 of the Result Notice No. 877 dated 24.06.2022, the recruitment process is kept opened for filling up of existing 04 vacancies under EWS category from the qualified candidates below the last shortlisted candidates in the merit. However, the validity of the waiting panel will remain the same i.e. upto 23.06.2023.
- 4. Further, based on the performance in the examination (online mode), more qualified candidates who obtained marks above or equal to minimum qualifying marks in each section (Part-I & Part-II separately) under EWS category below the last shortlisted candidates in notice dated 12.01.2022, are shortlisted for uploading of e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his/her online application form for the post of Assistant Teacher (Nursery), Post Code-43/21.
- 5. The cutoff marks for uploading of e-dossiers under EWS category only have been given as under:-

6. <u>The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the relevant documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability</u>

certificate/Proof of Govt. Servant/Ex. Servicemen/1st page of Admit Cards duly signed by the invigilator at the examination centre etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I written examination for 200 marks.

- 7. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 8. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time.
- 9. The e-dossier link shall be activated for a period of 15 days w.e.f. 08/07/2022 to 22/07/2022 only for EWS category candidates below last shortlisted candidate. Besides this, any candidate who was earlier shortlisted for uploading of e-dossier vide notice dated 12.01.2022 and gets SMS/Email for uploading of e-dossier, even if he/she filled the e-dossier or not, please ignore the message.
- 10. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 24/06/2021 as per Advertisement No. 02/2021. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. as an additional facility just for the facilitation of the candidates. But in case a candidate does not get any information on his/her registered mobile no./email id due to any reason, then it would not give any right to the candidate for extension of uploading of e-dossier. Therefore, if, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 11. Candidates are advised to visit website of the Board and OARS portal regularly for further information.
- 12. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 13. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 14. The above short listing of candidates for calling of e-dossier for the post of Assistant Teacher (Nursery), Post Code-43/21 in Directorate of Education is subject to outcome of pending court case, if any.
