## PHARMACIST (UNANI), POST CODE-19/21 IN DIRECTORATE OF AYUSH

The DSSSB vide advertisement No. 01/21 dated 04/03/2021 had advertised 14 vacancies (UR- 05, EWS - 01, OBC- 04, SC- 03, ST-01, inc PwD/OH - 01) for the post of Pharmacist (Unani), Post Code 19/21 in Directorate of AYUSH.

- 2. Online written examination for the post of Pharmacist (Unani) Post code 19/21 was held on 27/02/2022.
- 3. On the basis of written examination held on 27.02.2022 and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post of **Pharmacist**, **Post Code-19/21** and the terms and condition of the advertisement No. 01/2021, **the following 01candidate under SC category** is hereby provisionally nominated as per his/her merit, according to roll nos. of written examination of the candidate <u>subject to his/her fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in his/her online application form and e-dossier:-</u>

EWS Category: - No qualified /suitable candidate found in the merit.

UR Category:- No qualified /suitable candidate found in the merit.

OBC Category: - No qualified /suitable candidate found in the merit.

SC Category: - (01 candidate)

ST Category: - No qualified /suitable candidate found in the merit.

- 4. The selection of the above **01candidate under SC category** shall be subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 5. The selection of the above 01candidate under SC category candidates shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to his/her photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate (as the case may be applicable) as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates (as the case may be applicable) verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The category wise marks obtained by the last selected candidates are as under:-

12. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

## WAITING PANEL LIST

- 13. Further, in accordance with the Service Department Circular No. F.16 (3)/DSSSB/2007-S-III/1268 dated 13.06.2019, the Board prepares and maintains waiting panel /reserve panel and all the candidates above minimum qualifying marks in their respective categories are kept in waiting /reserve panel subject to call of e-dossier/verification of documents. The waiting panel is valid for a period of one year from the date of declaration of main result for filling up the vacancies arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc. within one year of validity of panel.
- 14. Now, in accordance with Services Department Circular No. F.16 (3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, the Board has decided that out of the waiting /reserve panel comprising all the candidates above minimum qualifying marks, the Board will also notify and nominate candidates to the extent of 20% of the notified vacancies as waitlisted candidates in order of merit after scrutiny of their e-dossier and share it with the User Department with a request to utilize the same in accordance with the services department Circular No. F.16(3)/DSSSB/2007/S-III.1268 dated 13.06.2019 and inconformity with DoPT guidelines and instructions of Govt. of NCT of Delhi issued from time to time and also mentioned from clause 1 to 19 of this result notice. However, as per merit list, no qualified / suitable candidate found in the merit in any category. Hence, no waiting panel is prepared.
- 15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage or arising due to court cases., if any.
- 16. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post code.
- 17. The recruitment process for the post of Pharmacist (Unani), Post Code-19/21 is hereby closed. Further, waiting panel could not be prepared due to non-availability of the qualified / suitable candidate in the merit in any category.
