2	111208700025	The candidate is overage by 03 year 05 months 29 days. He has uploaded GCT experience certificate for the period of:-21.08.2018 to 31.05.2019 (196 days), 01.07.2019 to 08.05.2020 (218 days), 15.07.2020 to 30.06.2021 (216 days) & 01.07.2021 to 30.04.2022 (211 days).
		The experience for the period of 21.08.2018 to 31.05.2019 (196 days), 01.07.2019 to 08.05.2020 (218 days) is considered which are as on cutoff date. However, experience for the period of 15.07.2020 to 30.06.2021 (216 days) & 01.07.2021 to 30.04.2022 (211 days) cannot be considered for being after cutoff date i.e. after 23.02.2020.
