OFFICE ORDER NO. 308 DATED 13-02-2013

## ORDER

The Hon'ble CAT, vide its order dated 09-08-2012 in OA No. in 2603/2012 titled Amod Singh Vs. GNCTD & Ors., has directed that:

- "4. ......we dispose of this OA at the admission stage itself permitting the applicant to make an appropriate representation to the respondents-DSSSB explaining as to how the qualifications he possesses are sufficient to meet the requirements as laid down in the recruitment rules. On receipt of such representation, the respondents-DSSSB shall consider the same and give a reasoned and speaking reply to the applicant within two months from the date of receipt of a copy of this order.
  - 1. It is informed that the representation dated 22-08-2012 submitted by the applicant was unsigned and, hence, the same was not considered.
  - 2. Now, the applicant has submitted a representation dated 18-01-2013 and in compliance of the above mentioned directions of the Hon'ble CAT, the same has been re-considered and following is informed to the applicant i.e. Sh. Amod Singh.
- As per RRs for the post, the following were the requisite essential qualifications for the post of Labour Welfare Supdt., Post Code-056/09.
  ESSENTIAL QUALIFICATION:-
  - 1. Degree of a recognized University or equivalent.
  - Post Graduate Degree/Diploma in Social Work OR
     Labour Welfare or Industrial Relations or Personal Management or
     in any other allied subject of a recognized university or equivalent.
     Desirable Qualifications:
  - 1. Degree in Law of a recognized university or equivalent.
  - 2. Experience in the field in responsible capacity of Labour Welfare/Industrial Relations/Personal Management and/or in allied fields.

- 4. In the instant case, the applicant i.e. Sh. Amod Singh, Roll No. 05610899 has done M.A (Sociology) and as such does not fulfil the requisite essential qualifications as per RRs for the post of Labour Welfare Supdt. under post code 056/09. It is, therefore, denied that the applicant meets all the requirements for selection to the said post. Further, as stated above also, the Board is merely a recruiting agency and it has to process the result of any post on the basis of Essential Qualification/Experience and other eligibility conditions as provided in the RRs for the post by the user department which is MCD in this case. Therefore, the applicant was not considered for selection for the said post and he was declared 'Not eligible' due to his qualification which was not as per RRs.'
- 5. That the Admit Card was issued to the applicant and Roll No. 05610899 was assigned to the applicant by the Board because no scrutiny of eligibility criteria of the candidate is carried out at the time of issuance of admit cards and the eligibility of the candidate is ascertained only before declaration of final result.
- 6. While preparing the result of post of Labour Welfare supdt., the eligibility of the candidates was checked with reference to the above requisite essential qualifications and only those candidates were declared eligible and provisionally selected whose qualifications were in conformity with the essential qualifications as provided in the RRs of the said post. The Board does not interpret the RRs of the post provided by the user department.
- 7. That by merely securing more marks than the last selected candidate, the applicant cannot claim that he is entitled for selection to the post as he is not eligible for the said post according to the RRs for the post submitted by the user department i.e. MCD. Further, the applicant belongs to UR category and in the said category, there were only 05 vacancies available. Out of the said 05 vacancies, 03 vacancies have already been filled up and there are as many as 21 candidates, above the applicant, in the merit list who have secured more marks than the applicant but could not be selected due to their qualification being not as per RRs for the said post. Moreover, the recruitment process in respect of post of Labour Welfare Supdt. under post

code 056/09 has been closed on 28-08-2012 with the approval of Competent Authority.

3. In view of the above, the case of Sh. Amod Singh cannot be considered for provisional selection for the post of Labour Welfare Supdt. under Post Code-56/09.
