**SUB: RELEASING OF MARKS AND CALLING OF E-DOSSIERS FOR THE POST OF
TGT, SPECIAL EDUCATION TEACHER IN DTE. OF EDUCATION, POST CODE 33/23.**

1. The DSSSB vide its advertisement No. 02/23 had advertised Total- 581 Vacancies UR-09, EWS- 96, OBC- 349, SC-34 & ST-93) for the Post of TGT, Special Education Teacher under Post Code- 33/23 in DOE, GNCT of Delhi.
2. The One Tier (Technical) CBT for recruitment in respect of this post was held on 24.06.2025, 26.06.2025 and 27.06.2025.
3. The normalized marks obtained by 3537 candidates out of Total 3544 appeared candidates have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dssbonline.nic.in.
4. As per the direction of the Ld. CAT in OA No. 2803/23 and OA No. 3064/23, the result of the concerned candidates have not been disclosed.
5. Based on the performance in the Online examination a total of **1076 candidates** who obtained marks above or equal to cut-off marks in their respective category, as detailed below, have been provisionally shortlisted as per policy to upload their requisite documents in e-dossier through the OARS module. All the 1076 shortlisted candidates for the above mentioned post code are hereby directed to login to the e-dossier module and upload all the documents of Educational certificates/mark sheets/Experience certificate/Category certificate/Admit card/proof of Govt. servant/Ex Serviceman/PwBD Certificate etc., as applicable, in the e-dossier module in OARS link in their individual accounts in OARS module.

6. As per the examination scheme, the mandatory minimum qualifying marks in Tier-I Examinations will be applicable only in r/o Section-B which is domain subject specific. There will not be any minimum qualifying marks in Section-A. However, combined aggregate marks of both Section-A (100 marks) & Section-B (100 marks) will be reckoned for preparing the final merit list.
7. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, subject to availability of vacancies, otherwise for selection in their respective category.
8. As per the Board Policy, the minimum qualifying marks in one Tier written examination for UR / EWS Category Candidate is 40%, for OBC candidate is 35% and for SC / ST/ PwBD Category Candidate is 30%.
9. Kindly note that the e-dossier link will be activated in r/o only those candidates who are

- provisionally shortlisted to upload e-dossier as per details given in Para 05 above.
10. All the candidates who have been shortlisted for uploading e-dossier **MUST** upload their all requisite/applicable documents in the said link within the stipulated time period.
 11. The e-dossier link shall be active from **19.06.2026 to 03.07.2026**. The candidate uploading e-dossier should ensure that she fulfils all the eligibility criteria/all essential qualifications as per RRs for the said post as on closing date of application i.e. 15.09.2023.
 12. The above short-listed candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID **as an additional facility**. If any candidate fails to upload the e-dossier during the above period, her candidature will be rejected and no further opportunity will be given on whatsoever ground.
 13. Further, in case the candidates are unable to upload the documents within above stipulated time period due to any technical glitch in OARS module, they may report the same within 48 hours after expiry of e-dossier submission period along with supporting evidence such as screenshots to e-mail of DSSSB helpdesk i.e. helpdeskdsssb@delhi.gov.in. The technical glitch shall be substantiated/ verified and only then, an addition period of 3 days will be granted for uploading the documents in e-dossier system.
 15. Mere asking the candidate for uploading documents in the e-dossier module does not confer her right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfils all the requisite eligibility conditions. It is reiterated that if the candidate fails to upload her documents on or before the date as mentioned above he will not be given any further opportunity and her candidature will be treated as cancelled.
 16. The above short-listing for calling of e-dossier for the post of TGT Special Education Teacher under Post Code- 33/23 in DOE, GNCTD will be subject to outcome of pending court cases OA No. 2803/23, 2288/25, 3064/23 and SLP (C) No. 16838/2025 connected matter with W.P. (C) 132/2016 and other court cases, if any in various courts.
 17. **Further the Final result /Recruitment process in r/o post code 33/23- Post TGT Special Education Teacher for DOE shall be subject to outcome of SLP NO. 16838/2025 Connected matter with W.P. (C) 132/2016 pending before the Hon'ble Supreme Court of India, and any other connected proceeding/ orders passed therein.**
 18. While every care has been taken in preparing the above shortlisting, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
