Sub:- Releasing of Marks of Objective Type (MCQ) examination for the post of Despatch Rider-cum-Process Server in Delhi High Court under Post code 54/25 and shortlisting of candidates for Stage-II (Skill Test).

1. The DSSSB vide its advertisement No.04/25 dated 21.08.2025 had advertised **Total-12 vacancies (UR-07, OBC-03, SC-01, EWS-01 Including ESM -01)** for the post of Despatch Rider-cum-Process Server in Delhi High Court under Post code 54/25.
2. The written examination (online mode) was conducted on **16.02.2026**. The marks obtained by **2854 candidates** who have duly appeared in examination (online mode) held on **16.02.2026** have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssonline.nic.in**
3. Based on the performance in the Objective Type (MCQ) examination (online Mode), a total of **170 candidates**, who obtained marks above or equal to cut-off marks in each category, as detailed below, have been provisionally shortlisted to appear for Stage-II (Skill Test), subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Stage-II (Skill Test) separately.

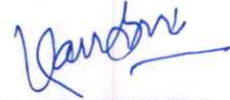
*A candidate bearing roll no. 250541210001549 in OBC category is not shortlisted as per Para 7 of Advt., as the candidate is born before 2.1.1995 (after availing age relaxation in OBC category).

4. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing for Stage-II (Skill test) does not entitle them any right over the post.
5. As per the Examination Scheme, the Objective Type (MCQ) examination of 100 Marks exam is taken. The qualifying criteria for next stage of Examination is, for General Category: 50 Marks (50% of 100), for Reserved Category (SC/OBC-NCL/EWS): 45 Marks (45% of 100) and for Ex-Servicemen category: 45 Marks (45%). Out of successful candidates, candidates to the extent of ten (10) times the number of vacancies advertised in each category are called for the next stage of the Examination.
