NOTICE NO. 1410 WARDER (MALE) IN DELHI PRISON DEPARTMENT POST CODE 37/2013

- 1. The DSSSB vide its advertisement No. 02/2013 with closing date 02/08/2013, had advertised 528 vacancies (UR-268, OBC-142, SC-79, ST-39 out of which 53 vacancies were reserved for EXSM) for the Post of Warder (Male) in Delhi Prison Department under post code 37/13.
- 2. That Sh. Sunil Kumar (Roll No. **3713021824**) applied for the post of Warder (Male), under Post Code 37/13) in Delhi Prison Department and appeared in Written exam on 02.03.2014.
- 3. Sh. Sunil Kumar (Roll No. **3713021824**) could not qualify the Physical Endurance Test (PET) on scheduled date i.e. on 18.03.2015 as his height was measured less than the qualifying measurement i.e. 170 cms. as per Advertisement for the post of Warder (Male), under Post Code 37/13.
- 4. Sh. Sunil Kumar filed O.A. No. 40/2016 & O.A. No. 3932/2017 titled as Sunil Kumar Vs GNCTD & Ors. Ld. Tribunal vide its order dated 06.01.2022 in O.A. No. 3932/2017 directed to refer the matter of the applicant, Sh. Sunil Kumar to an independent Government Hospital to constitute a review medical board for the purpose of determining applicant's height only. Therefore, a Medical Board was constituted in compliance of said order dated 06.01.2022 passed by Ld. Tribunal O.A. No. 3932/2017 titled as Sunil Kumar Vs GNCTD & Ors., which was also upheld by the Hon'ble High Court in WPC No. 7355/2022 GNCTD & Ors. Vs Sunil Kumar.
- A Medical Board constituted at Govind Ballabh Pant Institute of Post Graduate Medical Education & Research (GIPMER), measured the Height of Sh. Sunil Kumar as 170.5 cms., on 11.07.2022.
- 6. As per record, Sh. Sunil Kumar (3713021824) had qualified rest of requirement of the Physical Endurance Test (i.e. 1600 meters race in 06 minutes, 13 feet Long Jump, 3.9 Feet High Jump and Chest measurement Test) on the date of PET i.e. on 18.03.2015. Hence, Sh. Sunil Kumar (3713021824) is hereby declared as qualified the Physical Endurance Test for the post of Warder (Male), under Post Code 37/13) in Delhi Prison Department.

- 7. Based on the performance in the written examination and being qualified in PET, the candidate Sh. Sunil Kumar having roll no. 3713021824 is being provisionally shortlisted and accordingly allowed to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in his online application form.
- 8. The shortlisted candidate for the above-mentioned post/post code is hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Shortlisting is being made on the basis of marks obtained written examination and being also qualified in PET.
- The result status of the candidate is being uploaded in OARS module. Candidate can check his status by logging into his account in OARS module on www.dsssbonline.nic.in.
- 10. All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.
- 11. The e-dossier link shall be active from 06/09/2022 to 20/09/2022. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 02/08/2013.
- 12. The above shortlisted candidate is also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 13. All the candidates who have shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e. 06/09/2022 to 20/09/2022.
- 14. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her



documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.

- 15. The above short listing of candidate for calling of e-dossier for the post code -37/13 will be subject to outcome of pending court cases, if any.
- While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
