Further, the recognition of the Universities from which the degree/diploma/certificates have been submitted by the candidates should also be verified. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his/her appointment. Further, in case of the OBC candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. Of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993 O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt. (Res) dated 14.08.2008.

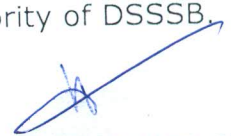
Note:
