**TGT (NATURAL SCIENCE) FEMALE, POST CODE-136/17 IN DIRECTORATE OF
EDUCATION**

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total **194 vacancies** [UR-112, OBC-33, SC-32 & ST-17 including PH/OH-03 & PH/VH-03] for the post of **TGT (Natural Science) Female under Post code-136/17** in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on **27.09.2018**.

2. **All 9526 candidates** who had appeared in written examination were informed through Notice No. F.No.182TGT (Natural Science)/Female/DSSSB/2018-19/326 dated 04/02/2019 on the Board's website www.dssbsonline.nic.in that their marks for the examination dated **27.09.2018** for the post of TGT (Natural Science) Male, Post Code-135/17 have been uploaded and the same were available in their account in OARS module. Further vide said notice, **414** shortlisted candidate were given the opportunity to upload their documents in the e dossier module w.e.f. **07/02/2019 to 16/02/2019** with specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. In all, a total of **369** candidates have uploaded their documents in the e dossier portal and **45** candidates failed to upload their documents.

3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following **180 (UR-103, OBC-27, SC-30, ST-16, PH/OH-03 & PH/VH-01)** candidates are provisionally nominated, as per their merit, to the post of **TGT (Natural Science) Female, Post Code-136/17** in Directorate of Education subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

4. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility

conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

5. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

6. The User Department shall also get the SC/ST/OBC certificates verified from the Issuing authority. Further, if applicable, User department shall verify the genuineness of the Caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, **DOPT O.M. No.36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No.36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and 36033/1/2013-Estt. (Res) dated 27.05.2013.**

7. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application for and e dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential certificates as per Instructions issued by Govt. of India in this regard vide **MHA OM No.2/29/54-RRs 19-11-54.**

8. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.

9. Further, the candidature of 09 candidates is kept pending for insufficient documents, as per details given below. They are directed to upload their pending/requisite/applicable documents in the e dossier module within the stipulate time, i.e. from 01/06/2019 to 10/06/2019.
