PHYSICAL EDUCATION TEACHER, POST CODE-90/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total **919** [UR-465, OBC-244, SC-141, ST-69] vacancies for the post of **Physical Education Teacher, Post Code-90/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on **16/09/2018**.

2. **All 8413 candidates** who had appeared in written examination were informed through notice No. F. No. 187/Physical Education Teacher/Int. Cell/Result/DSSSB/2018-19/1638 dated 23/04/2019 in supersession of previous notice dated 15/02/2019 on the Board's website i.e. www.dsssb.delhi.gov.in that their revised marks for the examination dated 16/09/2018 for the post of **Physical Education Teacher, Post Code-90/17** have been declared and the same were available in their account in OARS module. Further, vide said notice, **965 shortlisted** candidates were given the opportunity to upload their documents in the e-dossier module w.e.f. 27.04.2019 to 06.05.2019 with the specific direction that if any candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. In all a total of **883 candidates** have uploaded their documents in the e-dossier portal and **82 candidates** failed to upload their documents in the e-dossier.

3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following **725 Candidates (UR-449, OBC-113, SC-138, ST-25)** are provisionally selected for the post of **Physical Education Teacher, Post Code-90/17 in Directorate of Education** subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

6. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. No. 2/29/54-RPS, 19-11-54.**
10. **The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.**
