RESULT NOTICE NO. 7 8 (ASSISTANT TEACHER (NURSERY) UNDER-POST CODE-68/10, M.C.D.

- 1. In continuation of the result notice No. 426 dated 09.12.2015 and subsequent Result notice No. 451 dated 01.04.16, No. 539 dated 17.04.2017, No. 618 dated 26.03.2018 and No. 658 dated 28.05.2018 for the post of Assistant Teacher Nursery, Post code No. 68/10.
- 2. The DSSSB, vide its advertisement No. 02/2010 had advertised 381 vacancies (UR-208, OBC-111, SC-62 including PH-OH-15) for the post of Assistant Teacher (Nursery) under post code 68/10, in MCD, read with Notice dated 28/07/2017.
- 3. The DSSSB vide corrigendum No. F.4(126)/ P&P/2013/DSSSB/3419-21 dated 09.4.2013 has revised the vacancies in respect of PH Category only. Now, the vacancies in respect of PH-OH category may be read as 08 instead of 15 and PH-VH as 07. However, the total number of vacancies shall remain the same.
- 4. The result has been processed keeping in view of the eligibility conditions regarding educational qualifications / caste certificate / disability certificate etc. as on cut off date i.e. 15/09/17 for post code-16/17 and 30/07/2018 for post code-01/18
- 5. On the basis of marks secured in written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, **the following candidates are provisionally selected** to the post of Assistant Teacher (Nursery) under post code 68/10 in MCD, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their original application forms:-

- 6. The category of the candidate **having Roll No. 68007338** who had been selected earlier vide result notice dated 09/12/2015 has now been changed from SC to UR Category as per her merit in UR category. The User department is requested to update the records.
- 7. The category of the candidate **having Roll No. 68004346** who had been selected earlier vide result notice dated 09/12/2015 has now been changed from OBC to UR Category as per her merit in UR category. The User department is requested to update the records
- 8. The selection of the above 12 candidates (UR-07, OBC-09 and SC-02) shall be further subject to thorough verification of the candidature of the candidates by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 9. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. MCD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
 - 10.User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated

09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013.

- 11. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 12. The recruitment process for the post code-68/10 stands closed subject to outcome of pending court cases.
- 13. The above result for the post of Assistant Teacher (Primary) under post code 68/10 in MCD is subject to outcome of various pending courts cases (details of which are as under) and other related court cases, if any:-
