1. The DSSSB vide its advertisement number 01/2014 with closing date 27/02/2014, had advertised 04 vacancies (UR-03, OBC-01) for the Post of Stenographer, Grade-III in MAIDS under Post Code 152/2014. Vide addendum/corrigendum dated 25/07/2014, out of 04 vacancies for post code 152/2014, 01 vacancy was reserved for PH (OH) category. Board Conducted Tier I Written Examination for selection to the Post along with similar Post Codes on 11/06/2017. Board had declared marks of Tier I written examination of the Candidates of the Post of Stenographer, Grade-III in MAIDS under Post 152/2014 vide notice number 549 dated 06/10/2017.
2. The DSSSB vide Result Notice No. 748 dated 13/12/2018 has provisionally selected 02 candidates for the post of Stenographer, Grade-III in MAIDS under Post Code 152/2014.
3. Based on the performance in the One Tier Examination, 42 candidates were shortlisted for appearing in the Phase II of shorthand and typewriting skill test vide notice no. 750 dated 13/12/2018. The Skill test for shorthand and typewriting was conducted on 06/01/2019, wherein 29 candidates have appeared. The result of skill test was declared vide notice no. 786 dated 20/05/2019.
4. Candidates having roll no. 14316688, 14316981, 14317087 and 14316791 who qualified in Phase-I Skill test held between 08/02/2018 to 11/02/2018 have also been shortlisted for Post Code 152/2014 as per cut off marks in UR Category.
5. The Board has adopted the criteria for evaluation of the skill test on the pattern of SSC and considered up to 7% mistakes in Shorthand skill test for UR category and up to 10% mistakes in Shorthand skill test for all reserved category candidates, as qualified with a speed of 80 w.p.m. As per RR for the Post the candidate was to Qualify the 40 w.p.m. in Typewriting in English or 35 w.p.m. in Typewriting in Hindi, as well
6. As per RRs for the Post the candidate was to qualify the 40 w.p.m. in typewriting in English or 35 w.p.m. in typewriting in Hindi.
7. After preliminary scrutiny of the candidature of the candidates on the basis of documents uploaded by them in their e-dossier as per the provisions of the statutory Recruitment Rules for the Post and the terms and conditions of the advertisements, the following candidates are provisionally selected to the Post of Stenographer Grade III in MAIDS under Post Code 152/2014.

8. No suitable candidate found for selection in PH (OH) Category.
9. Candidature of 01 candidate having roll no. **14316688** is rejected as he has given preference for the Post Code 211/14 in his e-dossier, submitted between 26/07/2018 to 09/08/2018, and is already selected in post code 211/2014.
10. Candidature of 01 candidate having roll no. **14317087** is rejected in UR Category for failing to upload e-dossier during the scheduled time.
11. The Selection of the above 01 UR candidate shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide **MHA OM No. 2/29/54-RPS, 19/11/54.**
12. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency notices in the documents of the candidate at their own level.
13. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms *vis-à-vis* the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.

14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
15. If the candidate has any grievance regarding his/ her educational qualification/ age etc., he/she may approach the user department i.e. MAIDS for necessary clarifications as the eligibility has been checked as per the terms & conditions provided by the user Department.
16. The result is subject to the outcome of the court cases pending, if any, in various courts related to this post.
17. Further, waitlist/panel for the post code 152/14 shall be valid up to 16/06/2020.
18. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
19. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
20. This issues with the prior approval of the Competent Authority.
