REJECTION NOTICE NO. 797 CLERICAL ASSISTANT (POST CODE 153/2014) IN NEW DELHI MUNICIPAL COUNCIL

- 1. The DSSSB vide Result Notice No. 577 dated 17/11/2017 and Result Notice No. 699 dated 16/08/2018 has provisionally selected 57 candidates for the Post of CLERICAL ASSISTANT in NEW DELHI MUNICIPAL COUNCIL under Post Code 153/2014.
- 2. The One Tier Written Examination held on 30/08/2015 and the skill test were conducted as a combined examination for the post codes 49/2012, 153/2014 and 156/2014 of Shortlisted candidates on 09/04/2017 and 15/04/2018.
- 3. Vide Result Notice No. 699 dated 16/08/2018 candidature of below mentioned 03 candidates (OBC-02 and OH-01) were kept pending in their respective categories for following reasons for the Post Code.
- 4. The result of candidate having roll no. 10946905 was kept pending in OBC category for seeking the preference in between Post Code 153/2014 and 49/2012. Since the candidate has given his preference for Post Code 49/12, his candidature in Post Code 153/2014 is hereby rejected.
- 5. Further, the shortlist candidates were given opportunity vide notice no. 673 vide letter no. F. 1(330)/CC-II/DSSSB/2017/2924-31 dated 14/06/2018 to upload their documents in e-dossier module with effect from 20/06/2018 to 04/07/2018 with specific directions that if any candidates fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds. However, the following candidates have failed to upload their e-dossiers during the said period and therefore, their candidature is rejected for failing to upload their e-dossier during the schedule period i.e., 20/06/2018 to 04/07/2018;
