CLERICAL ASSISTANT (POST CODE 153/2014) IN NEW DELHI MUNICIPAL COUNCIL

- 1. The DSSSB vide Result Notice No. 577 dated 17/11/2017 and Result Notice No. 699 dated 16/08/2018 has provisionally selected 57 candidates for the Post of CLERICAL ASSISTANT in NEW DELHI MUNICIPAL COUNCIL under Post Code 153/2014.
- 2. The One Tier Written Examination held on 30/08/2015 and the skill test were conducted as a combined examination for the post codes 49/2012, 153/2014 and 156/2014 of Shortlisted candidates on 09/04/2017 and 15/04/2018.
- 3. The candidature of candidate having roll No. 10948926 was kept pending vide Result Notice No. 699 dated 16/08/2018 for seeking the preference of the candidate in between Post Code 153/14 and Post Code 156/14. Since no preference has been given by the candidate his candidature is hereby considered in post code 153/14 on the basis of e-dossier uploaded by the candidate in reference to the notice no. 673 dated 14/06/2018 in the Post Code 153/14.
- 4. Consequent upon rejection of candidature of 03 candidates (OBC-02, OH-01) and on the basis of the marks scored by the candidates in Tier-I Examination held on 30/08/2015, and thereafter qualifying the typing skill test, and after preliminary scrutiny of the documents in e-dossier, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement the following candidates are provisionally selected to the post of Clerical Assistant under post code 153/2014 in North Delhi Municipal Council from the existing waitlist panel, subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in their OARS.

- 5. If any candidate has any grievance regarding his/ her educational qualification/age etc., he/she may approach the user department i.e. New Delhi Municipal Council for necessary clarifications as the eligibility has been checked as per the terms & conditions provided by the user Department.
- 6. The Selection of the above 04 candidates (OBC-2, SC-1, OH-1) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 7. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency notices in the documents of the candidate at their own level.
- 8. It is stated that the User Department i.e. New Delhi Municipal Council shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment , the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.



- 10. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis- \hat{a} -vis the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 11. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 12. The result is subject to the outcome of the court cases pending, if any, in various courts related to this post.
- 13. Further, Waitlist/Panel for the Post Code 153/14 shall be valid up to 15/08/2019.
- 14. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
- 16. This issues with the prior approval of the Competent Authority.
