5. Further, the 1st recall notice dated 11/03/2022 may be considered revised as below:-

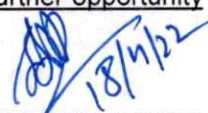
(i) The opportunity be considered as 1st opportunity at SI NO. 3 of the notice.

6. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 03/07/2021 as per Advertisement No. 03/2021.

7. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
