1. The DSSSB vide its advertisement number 02/2018 with closing date 13/08/2018 had advertised 79 vacancies (UR-47, OBC-19, SC-13 including EXSM-08, Sports-04, OH-01, HH-01, VH-01 AND AISLDMI-01) for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 20/18. Board Conducted Tier-I written examination for recruitment in respect of this post on 03/09/2019, 04/09/2019, 05/09/2019 and 06/09/2019. Board had declared marks of Tier I written examination of the Candidates of the Post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 20/18 vide notice number 856 dated 17/12/2019.
2. Based on the performance in the One Tier Examination, 938 candidates were shortlisted for appearing in Skill Test/Typing Test for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 20/18 vide notice number 856 dated 17/12/2019. The Skill Test/Typewriting Test was conducted on 22/12/2019, 23/12/2019 and on 16/02/2020 wherein out of 727 appeared candidates only 395 candidates could qualify. The result of skill test was declared vide notice no. 1045 dated 08/09/2020.
3. As per RRs for the Post the candidate was to qualify the 35 w.p.m. in typewriting in English or 30 w.p.m. in typewriting in Hindi.
4. On the basis of written Examination Tier-I held from 03/09/2019, 04/09/2019, 05/09/2019 and 06/09/2019 and being qualified in Skill Test held on 22/12/2019, 23/12/2019 and on 16/02/2020 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 02/2018 and RRs for the Post of Lower Division Clerk under Post Code 20/18 in Services Department, DSSSB vide Result Notice No. 1081 dated 19/11/2020, Supplementary Result Notice No. 1107 dated 16/02/2021, Supplementary Result Notice No. 1198 dated 27/07/2021 and Supplementary Result Notice No. 1236 dated 24/09/2021 has provisionally selected 73 candidates (UR-33, OBC-17, SC-13, EXSM-04, Sports-04, OH-01, HH-01) for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 20/18.

5. The User Department, i.e., Services Department, GNCTD vide letter dated 27/09/2021, 11/10/2021, 29/10/2021 and 05/11/2021 has returned dossiers of 08 provisionally nominated candidates (UR-04, OBC-03 and SC-01) on the grounds that selected candidates either did not accept the offer of appointment or did not respond within the specific period. The validity of the waitlist panel for the post code 20/18 is up to 18/11/2021 and the returned dossiers have been received prior to the expiry of waitlist panel, hence, candidate from waitlist panel have been considered for selection against the vacant posts created due to returned dossiers.

6. Now, in view of above-mentioned vacancies on the basis of written Examination Tier-I held from 03/09/2019, 04/09/2019, 05/09/2019 and 06/09/2019 and being qualified in Skill Test held on 22/12/2019, 23/12/2019 and on 16/02/2020 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 02/2018 and RRs for the Post of Lower Division Clerk under Post Code 20/18 in Services Department, the following Candidates are hereby provisionally nominated as per their merit, according to roll nos. of written examination of the candidates:-

7. The candidature of 02 candidates having roll no. 11150102863 earlier selected in SC Category and having roll no. 11140103078 earlier selected in OBC category are now shifted to the UR category as per their merit in the post code 20/18.

8. The User Department, i.e., Services Department is requested to thoroughly examine the sports field and sports person certificates provided by the above candidates from different associations/federations etc., in the light of para A (IV), (V) and Para H of DoPT O.M. F. No. 14034/01/2013-Estt. (D) Dated 3rd October, 2013 regarding consolidated instructions on incentives for Sports Persons in Government of India before issuance of any appointment letter. If any candidate does not fulfill the eligibility criteria with regard to sports person category his/her e-dossier may be returned after cancellation of his/her candidature at your level.

9. The candidature of candidates having roll number 11160102183, 12300115946, 11270103676, 12300111765 have already been considered under post code 02/17 of the post of Grade-IV (DASS)/Jr. Assistant, therefore they are not been considered under post code 20/18.
10. The selection of the above 08 candidates (UR-02, OBC-04 & SC-02) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
11. The Selection of the above 08 candidates (UR-02, OBC-04 & SC-02) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
12. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
13. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various

Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

14. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 and 13/05/2017.
15. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
16. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
17. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
18. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
19. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
