ORDER No. 329

The Hon'ble CAT vide its order dated 02.04.2014 in OA No. 1126/2014 titled Rahila Vs. South MCD & Ors:-

"In view of the circumstances and in the interest of justice, we dispose of the present OA, without going into the merits of the case, at the admission stage, by directing the respondents to consider the representations of the applicant and to pass a reasoned and speaking order given specific reasons for rejection of her candidature within a period of three weeks from the receipt of a copy of this order. It is also further directed that the respondents shall keep one post of Teacher (Primary-Urdu) post code No. 69/2009, vacant till they pass order on the representations of the applicant, as directed above".

1. In compliance of the above mentioned order of the Hon'ble CAT, the case of applicant i.e. Ms. Rahila has been reconsidered for the post Primary Teacher (Urdu), post code 69/09 and following are the facts:-
2. It is stated that the candidature of Ms. Rahila was rejected due to non fulfilling the requisite qualification.
3. South Delhi Municipal Corporation has provided a copy of letter from National Council for Teacher Education vide No. File No. 48-52/2013/NCTE/N&S/A82813 dated 11.02.2014, wherein they intimated that the Maulana Azad National Urdu University, Hyderabad has not been granted recognition for conducting DPE course under Distance mode. (Annexure- I & II).
4. That as per documents submitted by the applicant, she has done her diploma in Primary Education (DPE) from Maulana Azad National University, Hyderabad/IGNOU which is not recognized as per information provided by the User Department.

Keeping in view of the above fact Ms. Rahila was not considered, hence her candidature was rejected.

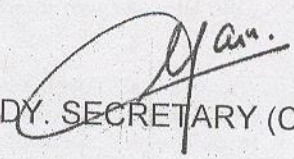

Sir,

I am directed to refer to the above cited letters on the aforementioned subject and to say that the recognition status of the DPE ODL Course conducted by Maulana Azad National Urdu University, Hyderabad/IGNOU has been sought from Regional Director, Southern Regional Committee (SRC), NCTE, Bangalore. The Regional Director vide his letter No. SRO/CTE/2013-2014/55332 dated 06.12.2013 has informed that the Maulana Azad National Urdu University has not been granted recognition by SRC, NCTE for conducting DPE Course under Distance Mode (copy enclosed).

2. In this context, your attention is drawn to the sub-section 4 of section 17 of NCTE Act, 1993 Act stipulating that the teacher training qualification obtained from an institution not recognized by NCTE after the appointed day i.e. 17/08/1995 will not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government (copy enclosed).
