CANDIDATURE CANCELLATION NOTICE No. 906

WARDER

In Delhi Prison Department,
Post Code 62/15

Attention is drawn to the Notice No. 816 dated 09/09/2019 vide which the marks of candidates were declared who appeared for the Online Examination held on 27/06/2019 for the Post of Warder in Delhi Prisons Department under Post Code 62/15. Attention is also drawn to the Result Notice No. 827 dated 11/10/2019 vide which results were declared for the Post of Warder in Delhi Prisons Department under Post Code 62/15.

2. However, subsequently, on analysis of Second Page of Admit Card while forwarding of e-dossier to the Delhi Prisons Department it has been found that Sh. RAKESH whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activities like Cheating, Impersonation, Forgery, Conspiracy, etc. during the above said post code exam:-

3. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

'Any attempt to commit or abet, as the case may be, all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to rendering himself/herself liable to criminal prosecution, be liable:

- To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared but the final result/selection has not been declared/made and or*
- To debarred either permanently or for a specified period which may extend to 10 years by the Board from any examination held or selection made by them and or,*
- To take disciplinary action under appropriate rules if he/she is already in service under Government and or,*

d) To take any other legal action.'

4. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post codes in online, offline and PET examination.

"If any case of impersonation comes to notice then overall in-charge and observer shall lodge FIR against both persons, i.e., candidate who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/Commissions."

5. Thus it is clear that the candidate had arranged to have another person taking examination in place of him. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i. Appearing in examination for another candidate or arranging to have another person take an examination for the candidate.
- ii. Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii. Helping or receiving help from other candidates/persons to impersonate.
- iv. Signing /getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v. Providing admit card and Aadhar Card (with change of photo) to another person to enable him to appear on behalf of the candidate.

6. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc. and produced this documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

7. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

8. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the Candidate.

9. The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, the candidature of the candidate **Sh. Rakesh, S/o Anand Singh, R/o VPO Dehkora, Distt. Jhajjar, Bahadurgarh, Haryana, 124501** having Date of Birth **21/04/1992** bearing roll no. **11160500201** of post code **62/15** is hereby cancelled and the provisional selection made vide Result Notice No. 827 dated 11/10/2019 of **Sh. Rakesh, S/o Anand Singh, R/o VPO Dehkora, Distt. Jhajjar, Bahadurgarh, Haryana, 124501** having Date of Birth **21/04/1992** bearing roll no. **11160500201** of Post Code **62/15** is hereby rescinded.

This issues with the prior approval of the Competent Authority.
