ORDER

SUB: Compliance of order dated 20.12.2022 passed by the Ld. CAT in OA No. 2899/2015 in the matter of Amit Kumar VS. Chairman, DSSSB & Ors.

WHEREAS, the Ld. CAT of Delhi vide its order dated 20.12.2022 in OA No. 2899/2015 in the matter of Sh. Amit Kumar Vs. Chairman, DSSSB & Ors., has directed as under:

"5.---The OA is disposed of accordingly with a direction to the respondents to dispose of the latest pending representation of the applicant dated 03.07.2015 within a period of 60 days from the date of receipt of a certified copy of this order".

- WHEREAS, this order shall dispose of the representation dated 03/07/2015 filed by Sh. 1. Amit Kumar (Roll No. 26002350), a candidate for the post of PGT (History) Male under Post Code-171/14 in Directorate of Education in compliance of the directions of Hon'ble Central Administrative Tribunal order dated 20.12.2022 in OA No. 2899/2015, in the matter of Amit Kumar Vs. Chairman, DSSSB and Ors.
- AND WHEREAS, The applicant vide his representation dated 03.07.2015 has stated that 2. he had applied offline for the vacancy of Post Code 138/12 PGT (History) against the advertisement no. 02/12 by DSSSB and later applied for the Post Code 171/14 for PGT (History) in 2014. Both the exams were held together but Post Code 138/12 was not included in his admit card against which he gave the examination with Roll No. 26002350. He had requested DSSSB through letter dated 01/12/2014 for addition of Post Code 138/12 for the said examination. However DSSSB has declared the Tier I result Notice No. 393 Dated 03.06.2015 where he had been shown successful only for Post Code 171/14 and Post Code 138/12 was not included as the name of Sh. Amit Kumar is not found in the Data base of I.T. Branch forwarded by the Secret Cell. He had therefore requested vide representation dated 03.07.2015 for including the Post Code 138/12 for the said examination and result.
- 3. AND WHEREAS, In this regard, The DSSSB vide important notice no. 483 dated 16.09.2014 for the candidates of post codes 122/12 to 156/12 (PGTs), 48/12, 68/12,52/12,157/12 (LDCs), 14/12 (J.E. E& M) & 21/12 (MVI) of advt. no. 2/12 informed that DSSSB has now switched over to Online Application Registration System (OARS), applicants for these post codes, who had applied through paper based forms

are now required to get themselves registered in OARS software and upload their "photograph, signature and Educational qualification/experience online for issuance of admit cards through OARS. Candidates who fail to register in OARS will not be issued admit cards.

- 4. AND WHEREAS, for which repeated notices have been issued and published in the News papers and also on the website of DSSSB dsssb.delhigovt.nic.in. Initially the date for digitization of applications of various posts was 19/09/2014 to 15/10/2014 03.11.2014 (For to extended repeatedly which was 48/1,68/12,52,12,122/12-156/12,14/12,21/12). Further it was widely publicised that candidates who fails to upload the above particulars will be treated as non-interested candidates and his/her candidature shall stand cancelled. Help desk was also set up in DSSSB office to help the candidates who face problem in filling up of their particulars in the digital form. As per OARS portal Sh. Amit Kumar has applied for the post codes 171/14, 112/17, 118/12 and it is clear that he has not registered in OARS software and not uploaded his "photograph, signature and Educational qualification/experience online for issuance of admit card through OARS under post code 138/12, therefore his candidature was not considered for the said post code.
- 5. AND WHEREAS, that in compliance of order dated 20.12.2022 of Hon'ble Tribunal in OA No. 2899/2015 the representation/case of applicant under the post code 138/12 has been examined and following is stated in this regard:
- **6.** AND WHEREAS, the Board had advertised/published the vacancies for the post of PGTs vide advertisement No. 02/12 for filling up the various posts and for the same the applications were invited from the eligible candidates. The vacancy positions are as under:

7. AND WHEREAS, the prescribed cutoff date for determining the eligibility of the candidates in r/o different post codes is mentioned as below:

8. AND WHEREAS, the Board had conducted the Tier-I examination on 30.11.2014 for the various post of PGTs in Directorate of Education subsequently, the marks obtained by the candidates a combined list of all candidates were uploaded on the website of the Board for the information of all concerned.

- **9.** AND WHEREAS, as per the terms & conditions laid down the exam scheme, the minimum standard of marks for short listing the candidates on the basis of examination is fixed as 40% for UR category, 35% for OBC, 30% for SC/ST/PH and EXSM will be given 5% relaxation in their respective categories subject to a minimum of 30% for reserved categories.
- **10.** AND WHEREAS, the result of Tier-I examination has been processed and ten times of vacancies (category wise) have been shortlisted for Tier II Exam.
- 11. AND WHEREAS, Sh. Amit Kumar, Roll No. 26002350 copy of admit card, has obtained 109.75 marks in the post code 171/14 PGT (History), in SC category the cut of marks in SC category is 108 marks; hence he has shortlisted for Tier-II Exam. It is also pertinent here that in the post code 138/12 the name of Sh. Amit Kumar is not found in the Data base of I.T. Branch. Thus the question of his being shortlisted in this post code does not arise.
- **12.** AND WHEREAS, Keeping in view the facts explained above, the Board has rightly denied for consideration of candidature of Sh. Amit Kumar (Roll No. 26002350) in post code 138/12 post of PGTs in Directorate of Education, hence his request vide representation dated 03/07/2015 cannot be accepted.
- **13.** NOW, THEREFORE, In view of above the candidature of applicant /petitioner, Sh. Amit Kumar, Roll No. 26002350, has been examined, considered and not found admissible for the Post of PGT (History) in Directorate of Education under Post Code 138/12 in view of the facts mentioned above, hence rejected.

This issues with the approval of the Chairman, DSSSB.
