NOTICE/CORRIGENDUM TEACHER (PRIMARY) -POST CODE-70/09 MUNICIPAL CORPORATION OF DELHI

The result of post code 70/09, on the basis of written examination held on 02-02-2014 and eligibility regarding educational qualifications, age etc. as per Advertisement No. 004/09 and RRs for the post of Teacher (Primary), MCD was declared & published on the website of Board vide office order no. 343 & 344 dated 05/12/2014.

It has been noticed that few inadvertent discrepancies have crept in during the course of preparation of result mentioned as under.

- 1. Two candidates have been selected twice in two different categories whose details are as under:
 - a. Ajay Kumar bearing roll no. 07096407 found in SC category at Sl. No. 325 & PH (OH) category at Sl. No. 41,
 - b. Rakesh Kumar bearing roll no. 07091830 found in SC category at Sl. No. 152 & PH (OH) category at Sl. No. 22.

Thus result of Sh. Ajay Kumar bearing roll no. 07096407 may be considered in SC category at Sl. No. 325 & not in PH (OH) category at Sl. No. 41 whereas result of Sh. Rakesh Kumar bearing roll no. 07091830 may be considered in SC category at Sl. No. 152 & not in PH (OH) category at Sl. No. 22.

- 2. One candidate viz. Sh. Satyawan, Roll No. 07054161 has been selected in UR category at Sl. No. 879 but as per documents enclosed in the dossier his DOB is 10/04/79 i.e. he is over aged & thus his candidature is rejected.
- 3. One candidate viz. Sh. Karamvir, Roll No. 07077827 has been selected in OBC (OH) category is to be considered in UR (OH) category.
- 4. One candidate viz. Ashok Kumar, Roll No. 07085545 has been selected in SC category at Sl. No. 51. He is an outsider SC candidate & thus he is considered as pending.

5. Result of one candidate namely Sachin bearing roll no. 07088375 was kept pending & now is being declared as provisionally selected.

Rest of the contents of the notices 343 & 344 remain unchanged. This issues with the prior approval of the Competent Authority of DSSSB.
