Also, the SC candidates who have secured marks above the cutoff marks of UR category in Part-II, but were not shortlisted in Part-I in UR category, have finally been selected in their own category only.

Further, the result of following 01 candidate under post code 106/07 has been kept pending for recasting of his Application Form/Dossier and he is hereby directed through this result notice, to visit the Board Office with all his original and attested copies of educational qualification/ experience/caste certificate and two attested colour passport sized photographs on any working day between 10.00 AM to 5.00 PM within 15 days of the issue of this notice.

For admissibility of benefit of reservation, the result has been processed as per the judgment of Hon'ble Supreme Court of India dated 04.08.2009 as passed in Civil Appeal No. 5092 of 2009 arising out of Petition (s) for Special Leave to Appeal (Civil) No.(s) 24327/05-Subhash Chandra & Anr. V/s DSSSB & Ors. with WP(C) No. 507 of 2006 – sarv Rural & Urban Welfare Society Vs Union of India & Ors. and in the absence of a Presidential notification under Article 342 of the Constitution of India declaring any tribe to be a ST in the UT of Delhi, the result of ST category has been rejected.

The user Department shall also get the caste certificates verified from the issuing authority before their appointment. Further, in case of OBC candidates, it may be verified that the candidate does not belong to the persons/sections (Creamy layer) mentioned in column 03 of the Schedule to the Govt. of India, Deptt. of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 14.10.2008.
